Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. # SPECIAL TERMS & CONDITIONS (SCC) & Technical Specification

# 1. TERMS OF PAYMENT:

- (a) 100% FOR price excluding GST shall be released within 90 days (45 day s for MSE, 60 days for Medium Enterprises) after receipt & acceptance of materials at site and on submission of GST invoice along with material re ceipted challan. For payment vendor shall submit Original Invoice along with receipted delivery challan to BHEL North Karanpura STPP site for fur ther processing of bill by North karanpura site.
- (b) GST portion of invoice shall be released only upon: -
  - (i) Such invoice appearing in GSTR-2A of BHEL on filing of valid returns by vendor as per GST law within timeline prescribed for availing ITC by BHE L, and
  - (ii) Receipt of goods / services and Tax invoice by BHEL, a nd
  - (iii) Confirmation of payment of GST thereon by vendor on GSTN portal.

No advance payment shall be made.

Paying Authority: RAO, BHEL North Karanpura STPP site.

Any Interest if levied thereon for reasons elaborated in tax & duties clause of the tender and attributable to the bidder, will be recovered from the Final Payment / Retention amount.

### 2. TAXES & DUTIES:

2.1 The contractor shall pay all taxes, fees, license, charges, deposits, dutie s, tools, royalty, commissions, other charges, etc. which may be levied on the input goods & services consumed and output goods & services deliver ed in course of his operations in executing the contract. In case BHEL is fo rced to pay any of such taxes/duties, BHEL shall have the right to recover the same from his bills or otherwise as deemed fit. However, provisions r egarding GST on output supply (goods/service) and TDS/TCS as per Incom e Tax Act shall be as per following clauses.

## 2.2 GST (Goods and Services Tax)

- 2.2.1 GST as applicable on output supply (goods/services) are include in contra ctor's/supplier's scope; therefore, contractor's/supplier's price/ rates shall be i nclusive of GST. Reimbursement of GST is subject to compliance of following t erms and conditions. BHEL shall have the right to deny payment of GST and to recover any loss to BHEL on account of tax, interest, penalty etc. for non-compliance of any of the following condition.
- 2.2.2 Contractor has to submit GST registration certificate of the concern ed state.

Contractor also needs to ensure that the submitted GST registration certificat e should be in active status during the entire contract period.

- 2.2.3 TDS as applicable under GST law shall be deducted from contractor's bill.
- 2.2.4 Contractor shall comply with the provisions of e-way bill wherever ap plicable.

Further wherever provisions of GST Act permits, all thee-way bills, road permits etc. required for transportation of goods needs to be arranged by the contractor.

- 2.2.5 In the event of any ambiguity in GST law with respect to availability of input credit of GST charged on the invoice raised by the contractor or with re spect to any other matter having impact on BHEL, BHEL's decision shall be final and binding on the contractor.
- 2.2.6 In case the vendor is not required to prepare invoice in terms of Rule 48(4), a declaration regarding the same to be submitted along with the invoice.
- 2.3 Income Tax: TDS U/S 194Q as applicable under Income Tax Act, 1961 or rule s made there under shall be deducted from contractor's bill.

3. Chemicals are to be dispatched in suitable packaging (preferably 25 Ltr Plastic Jar /Can) to protect any loss, damage, corrosion in transit etc. Chemicals are to be accompanied with Test Certificate, MSDS etc. Detail s of chemicals should be printed on jars/containers and the same shall be linked to the test certificates sent along with chemicals.

### 4. **INSPECTION & TESTING:**

Chemicals are to be tested at BHEL/ Customer recommended lab or any other Govt,/ NABL accredited Lab. Cost towards sample collection, testing at laboratory etc will be borne by bidder within his total accepted price. S ample collection may have to be done in presence of BHEL representative, if required.

Concentration of chemical may again be verified at site in presence of bid der's representative, if required. If the test fails at site the bidder shall m ake good of the chemicals found lower in concentration or short in quanti ty as compared to the desired concentration within a period of one week failing which BHEL reserves the right to procure the same at vendor's risk & cost. The chemical resupplied by the vendor is to be tested again upon delivery at site, the cost of which will be borne by the vendor.

### DELIVERY PERIOD:

All the chemicals are to be delivered at North Karanpura site within 30 days from issuance of Purchase Order.

Dispatch is to be made against Material Dispatch Clearance Certificate (MDCC) from BHEL. Test certificate along with manufacturing report containing manufacturing date, shelf life period and expiry date shall be submitted for issuing of MDCC.

Material to be dispatched only after issuance of MDCC by BHEL.

## 6. **EVALUATION CRITERIA:**

BHEL reserve the right to purchase from elsewhere on account of and at the risk & cost of the vendor with notice to the vendor of the equipment/materials not so delivered, with/without canceling the order/contract in respect of the equipment/materials not yet due for delivery.

13. The scope of unloading at site is excluded from the scope of seller.

Quantity variation is not envisaged for this contract. Supply quantities should be limit ed to ordered quantities.

#### 11. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

#### 12. Certificates

Material Test Certificate Should Be Sent Along with The Supply. The Material Will Be Checked by Buyer's Lab & the Results of the Lab will be the Sole Criteria for Acceptance of the Item.

# Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
