Bidder to note that Deviation/s shall not be permitted for the below mentioned terms and are deemed to be complied. In case of non-compliance/deviation, offer may be liable for rejection

1. <u>Terms of Payment for Supply</u>: : 80% payment of Supply value shall be made within 45 days-MSE/ 60 days-Medium/ 90 days-Non MSME, from the date of receipt of material at BHEL. Balance 20% of Supply value p lus 100% of the E&C portion of PO value will be paid against E&C certificate issued by BHEL and submission of Performance Bank Guarantee (PBG) valid for 30 days beyond the warranty period by Supplier from any of the Consortium Banks of BHEL for 10% of total PO Value in the prescribed Format. The PBG confirmation charges shall be borne by vendor.

Penalty for Delay in 'SUPPLY' and 'E&C':

- a. For the purpose of penalty for delay E&C of the equipment the duration will be reckoned from the date of intimation by BHEL to vendor for readiness of site.
- b. Penalty on delay in 'Supply' and/or 'E&C' will be applicable to the delays attributed to vendor. Penalty will be considered separately for 'Supply' and 'E&C'.

2. <u>Pre-dispatch inspection at Seller premises</u>: Before dispatch, the goods will be inspected by Buyer / Consi gnee or their Authorized Representative or by Nominated External Inspection Agency (independently or join tly with Buyer or Consignee as decided by the Buyer) at Seller premises (or at designated place for inspecti on as declared / communicated by the seller) for their compliance to the contract specification. For in-house testing, the Sellers will provide necessary facilities free of cost.

Seller shall notify the Buyer through e-mail about readiness of goods for pre-dispatch inspection and Buyer will notify the Seller about the Authorized Representative/ Nominated External Inspection Agency and the date for testing. While bidding, the sellers should take into account 10 days for arranging inspection from the date of email offering the goods for inspection. Any delay in arranging inspection beyond 10 days due to reas ons not attributable to seller, shall be on the part of buyer and BHEL will extend the delivery period for such period of delay.

The goods would be dispatched to the consignee only after clearance in pre-dispatch inspection. Consignee's right of rejection as per GTC in respect of the goods finally received at his location shall in no way be limited or waived by reason of the goods having previously been inspected, tested and passed by Buyer/ Consignee or its Nominated External Inspection Agency prior to the goods' shipment.

- 3. <u>Shortages</u>: In the event of shortage on receipt of goods and/or on opening of packages, all such shortage s, caused by supplier's act or omission, shall be made good at free of cost within a reasonable time that BH EL may allow from such intimation.
- 4. <u>Transit Damages</u>: In the event of receipt of goods in damaged condition or having found them so upon op ening of packages , supplier shall make good of all such damages within a reasonable time from such intim ation by BHEL.
- 5. <u>Dispatch documents</u>: Complete set of dispatch documents (original + 1 photocopy set) as per Purchase Order shall be forwarded to Purchase Officer/BHEL directly. Dispatch documents shall include the following:

6. After award of contract, Successful Bidder shall submit complete set of documents (like drawings, bill of materials, datasheets, catalogues, quality plan etc. as called in tender specification) for approval, within 10

days of award of contract. Buyer shall issue manufacturing clearance along with approved documents within 60 days from receipt of complete set of documents from seller. Any delay in providing approved documents beyond 60 days shall be on the part of buyer and BHEL will extend the delivery period for such period of del ay.

In case of any corrections in documents to be incorporated by seller for approval of document based on end -user/consultant/buyer comments, revised documents have to be submitted incorporating all corrections wit hin 06 days. Seller shall be required to commence manufacturing only after receipt of approved documents from BHFL.

7. <u>Packaging and dispatch</u>: The Seller shall package the goods safely and carefully considering the peculiari ty of the material for safe transport by Road to its destination suitably protected against loss, damage, corro sion in transit and the effect of tropical salt laden atmosphere. The packages shall be provided with fixtures/ hooks and sling marks as may be required for easy and safe handling. If any consignment needs special han dling instruction, the same shall be clearly marked with standard symbols / instructions. Hazardous material should be notified as such and their packing, transportation and other protection must conform to relevant r egulations.

The packing, shipping, storage and processing of the goods must comply with the prevailing legislation and r egulations concerning safety, the environment and working conditions. If safety information sheets (MSDS – Material Safety Data Sheet) exist for an item or the packaging, vendor must provide this information without fail along with the consignment.

Each package must be marked with Consignee name, Purchase order number, Package number, Gross weig ht and net weight, dimensions (LxBxH) and Seller's name. Packing list of goods inside each package with PO item number and quantity must also be fixed securely outside the box to indicate the contents of each box.

Total number of packages in the consignment must also be indicated in the packing list.

8. Conflict of Interest among Bidders/Agents:

"A bidder shall not have conflict of interest with other bidders. Such conflict of interest can lead to anti-com petitive practices to the detriment of Procuring Entity's interests. The bidder found to have a conflict of interest shall be disqualified. A bidder may be considered to have a conflict of interest with one or more parties in this bidding process, if:

- a) they have controlling partner (s) in common; or
- b) they receive or have received any direct or indirect subsidy/ financial stake from any of them; or
- c) they have the same legal representative/agent for purposes of this bid; or
- d) they have relationship with each other, directly or through common third parties, that puts them in a posi tion to have access to information about or influence on the bid of another Bidder; or
- e) Bidder participates in more than one bid in this bidding process. Participation by a Bidder in more than o ne Bid will result in the disqualification of all bids in which the parties are involved. However, this does not li mit the inclusion of the components/ sub-assembly/ Assemblies from one bidding manufacturer in more than one bid; or

# 12. Turnover

- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
