1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. 2. 3. Conflict of Interest among Bidders/ Agents

A bidder shall not have conflict of interest with other bidders. Such conflict of interest can lead to anti-competitive practices to the detriment of Procuring Entity's interests. **The bidder found to have a conflict of interest shall be disqualified.** A bidder may be considered to have a conflict of interest with one or more parties in this bidding process, if:

- a) they have controlling partner (s) in common;**or**
- b) they receive or have received any direct or indirect subsidy/ financial stake from any of them**or**
- c) they have the same legal representative/ agent for purposes of this bid;**or**
- d) they have relationship with each other, directly or through common third parties that puts them in a position to have access to information about or influence on the bid of another Bidder; **or**

Participation by a Bidder in more than one Bid will result in the disqualification of all bids in which the parties are involved.
