### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

Buyer Added text based ATC clauses

#### 1) Pre-Qualification Criteria:

**1a)** Vendor should submit at least one PO copy which indicates the supply of UPS Batteries (12V - 26Ah or above) in last 5 years from the date of enquiry.

**1b)** The condition of Prior Turnover and prior experience is relaxed for all start-ups whether Micro & Small Enterprises (MSEs) or otherwise subject to meeting of quality and technical specifications in accordance with the relevant provision of GFR,2005 and other DOE-PPD notifications for relaxation norms for start-ups issued from

time to time.

**2) Payment term:** 100% Basic value shall be made within stipulated time from the date of installation and acceptance of material at BHEL R&D, Vikas Nagar, Hyderabad and submission of Performance Bank Guarantee (PBG) by supplier in the prescribed format.

**Type of bidder:**

A. For Micro & Small enterprises(MSEs) payment will be made within 45 days

B. For Medium Enterprises will be made within 60 days

C. Non MSMEs will be made within 90 days However, GST Portion of Invoice shall be released only upon:

i) Vendor declaring the Invoice in their GSTR-1.

ii) Receipt of Goods and Tax Invoice by BHEL.

iii) Confirmation of Payment of GST thereon by vendor on GSTN.

**3) Performance Bank Guarantee (PBG):** PBG of 10% of total order value is to be submitted by the successful vendor and shall be kept valid up to guarantee/warranty period with additional claim period of 3-6 months thereafter. The offers of the suppliers not accepting to this clause will be rejected.

**4) Interest for delayed submission of performance security (PBG):** PBG of 10% of total order value is to be submitted by the successful vendor within 15 days from the date of completion of entire scope. Bidder agrees to submit performance security required for execution of the contract within the time period mentioned. In case of delay in submission of performance security, enhanced performance security which would include interest (SBI rate + 6%) for the delayed period, shall be submitted by the bidder. Further, if performance security is not submitted till such time the first bill becomes due, the amount of performance security due shall be recovered as per terms defined in NIT/contract, from the bills along with due interest.

**5) Restriction:** Submit the Annexure - A which is attached in ATC document.

**6)** Submit the Annexures B&C which are attached in ATC documents as per the instructions mentioned.

**7) Delivery period:** The delivery period 21 days (from PO date) is for complete scope as mentioned in Additional Specification parameters.

**8)** List of serial numbers of old batteries is as per Annexure-D in ATC document.

## **Disclaimer/अस्वीकरण**

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms &

Conditions, in contravention to exemption provided to such sellers under GeM GTC.
