2. Scope of Supply

Scope of supply (Bid price to include all cost components): Only supply of Goods

3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1. Payment Terms :100% of basic price of material supplied, as per PO, along with 100% taxes & duties (as applicable) & freight charges, shall be paid on pro-rata basis within
- (i) 45 days for Micro & Small Enterprises (MSEs)
- (ii) 60 days for Medium Enterprises
- (iii) 90 days for Non-MSME

from the date of receipt of goods & receipt of complete documents as per order/contract subject to acceptance of materials. Statutory deductions will be made from payment, certificate if any will be issued by BHEL.
