SCOPE:

This specification covers the technical requirements for Diode ORing Module.

TECHNICAL DETAIL:

The power supply unit shall meet the following minimum requirements.

- 1) Input: Two no. of 24VDC, 20A Switched Mode Power Supply Units. The module shall be suitable for paralleling of 2no. SMPS Modules for redundancy purpose.
- 2) Output: 24 VDC, 20A. The output capacity from diode Oring unit when both inputs are healthy or one input is healthy (available) shall be 20A.
- 3) The Diode ORing shall be suitable for mounting on a 35mm DIN rail.
- 4) For all connections including Input/Output/monitoring, suitable provisions shall be provided on the front plate.
- 5) Cable entry shall be from the top/bottom.
- 6) Enclosure: Ventilated, Natural air-cooling when housed in Control cabinet of IP42 protection.
- 7) Operating temperature = 0~55 degC
- 8) Indications: LED indications for Input1, Input2 and Output. Supplier to indicate the details of LED indications in the front of the module offered.
- 9) Inrush current: maximum to twice the continuous rating.
- 10) The Diode ORing module should have batch number/month & year of manufacturing printed on it.
- 11) One no. NC contact for each power supply failure monitoring.
