1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1) Restriction: Submit the Annexure A which is attached in ATC document
- 2) BHEL GSTIN registration number is 36AAACB4146P1ZG
- 3) Submission of earnest money deposit (EMD) along with offer is required. EMD is to be deposited in cash (as permissible under IT act), or by payorder/Demand Draft drawn in favour of BHEL R&D-A/c 1020216264 0,Vikasnagar,Hyderabad 500093. EMD amount will be returned to all unsuccessful bidders after placemen t of order. EMD amount shall not carry any interest. EMD by the Tenderer will be forfeited as per NIT conditions, if:
- i) After opening the tender and within the offer validity period, the tenderer revokes his tender or makes a ny modification in his tender which is not acceptable to BHEL.
- ii) The Contractor fails to deposit the required Security deposit or commence the work within the period as per LOI/ Contract. EMD by the tenderer shall be withheld in case any action on the tenderer is envisaged u nder the provisions of extant "Guidelines on Suspension of business dealings with suppliers/ contractors" a nd forfeited/ released based on the action as determined under these guidelines. EMD amount is Rs. 2,800/

4) Security Deposit clause:

4a) Successful bidder shall submit a security deposit at the time of release of order and the amount will no t carry any interest. The amount of security deposit will be 5% of the contract value. EMD of the successful tenderer shall be converted and adjusted towards the required amount of sec urity deposit (SD).

MODES of DEPOSIT: The balance amount to make up the required Security Deposit of 5 % of the contract v alue may be accepted in the following forms:

- i) Cash (as permissible under the extant Income Tax Act)
- ii) Local cheques of Scheduled Banks (subject to realization)/ Pay Order/ Demand Draft/ Electronic Fund Transfer in favour of BHEL R&D ❖ A/c 10202162640
- iii) Bank Guarantee from Scheduled Banks/ Public Financial Institutions as defined in the Companies Act. The Bank Guarantee format should have the approval of BHEL
- iv) Fixed Deposit Receipt issued by Scheduled Banks/ Public Financial Institutions as defined in the Companies Act (FDR should be in the name of the Contractor, a/c BHEL)
- v) Securities available from Indian Post offices such as National Savings Certificates,
- 5) Interest chargeable on Delay in Submission of Security Deposit: SD is to be submitted by the successful vendor within 15 days from the date of order. Bidder agrees to submit security deposit required for execut ion of the contract within the time period mentioned above. In case of delay in submission of performance security, enhanced amount which would include interest (SBI rate + 6%) for the delayed period, shall be s ubmitted by the bidder. Further, if SD is not submitted till such time the first bill becomes due, the amount of SD due shall be recovered from the bills along with due interest.
- 6) Vendor has to submit this GeM bid document duly signed and stamped on all pages. By submitting sign ed GeM bid it affirms that vendor has accepted to all the terms and conditions mentioned in this bid such a s specifications, scope of work, Payment terms, delivery period etc.
- 7) This bid is for wire cutting of 8 Nos of Rotor laminations. Vendor has to quote Lumpsum amount inclusive of GST, to and for transportation, insurance and other applicable charges.
- 8) Transportation & Insurance: Transportation and transit insurance of raw material from BHEL R&D to suppliers work and machined material from supplier's work to BHEL R&D shall be in supplier scope only.

- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export

experience.

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
