(A) Benefits to MSE vendor:

1. Payment to MSE vendor will be as per the applicable provisions of MSMED Act.
 - a. For Micro and Small Enterprises, 100% payment will be released within forty-five (45) days of issue of consignee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills.
