### **1.0 Past Experience of Similar Services:**

Bidders should have Experience of having successfully completed similar works during the last 7 years prior to enquiry date, should be either of the following: a. Three similar completed works each costing not less than the amount equal to Rs. 4.32 lakhs (or) b. Two similar completed works each costing not less than the amount equal to Rs. 5.40 lakhs (or) c. One similar completed work costing not less than the amount equal to Rs. 8.64 lakhs.

Similar works means "**outsourcing of Paramedical Services**". Order copies and completion certificate where work has been executed to be submitted for compliance.

### **2.0 Annual Turnover:**

Bidder should have Average annual turnover (for 3 year) is 3.24 lakh.
