1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. 2.14 Conflict of Interest among Bidders/ Agents:

A bidder shall not have conflict of interest with other bidders. Such conflict of interest can I ead to anti competitive practices to the detriment of Procuring Entity's interests. Participation by a Bidder in more than one Bid will result in the disqualification of all bids in which the parties are inv olved. However, this does not limit the inclusion of the components/ sub-assembly/ Assemb lies from one bidding manufacturer in more than one bid; or
- f) In cases of agents quoting in offshore procurements, on behalf of their principal manufac turers, one agent cannot represent two manufacturers or quote on their behalf in a particul ar tender enquiry. 2.17 Breach of contract, remedies & termination

In case of delays in completion of works or non-fulfilment of any other terms and conditions of the Contract as enumerated subsequently in this clause, then, without prejudice to its rig ht to recover any expenses, losses or damages to which the Buyer may be put to incur or s ustain by reason of the Seller/Contractor's default or breach of Order/Contract or to suspen d business dealings with the Seller/Contractor in terms of the Buyers' Guidelines for Suspen sion of Business Dealings as applicable from time to time, the Buyer shall also be entitled to cancel the Order/ Contract either in whole or portion thereof without compensation to Sell er. On the occurrence of any of the acts/omissions mentioned below, the Buyer may if it so desires, procure upon such terms and in such manner as deemed appropriate, plant/ equip ment/ stores not so delivered or others of similar description where plant/ equipment/ store s exactly complying with particulars are not, in the opinion of the Buyer (which shall be fina l), readily procurable.

Seller shall continue the performance of the Order/Contract to the extent not cancelled und er the provisions of this clause. The Seller shall on no account be entitled to any gain on su ch repurchases.

BHEL reserves the right to terminate the contract partially / totally or withdraw portion of w ork and get is done through other agency after due notice of a period of 14 days by BHEL i n any of the following cases:

- i) If the Seller/Contractor fails to deliver the goods or materials or any instalm ent thereof within the period(s) fixed for such delivery or the Seller's poor progre ss of the supply/services vis-à-vis delivery/execution timeline as stipulated in the contract, backlog attributable to the Seller including unexecuted portion of supply does not appear to be executable within balance period available;
- ii) delivers goods or materials not of the contracted quality and failing to adhe re to the contract specifications/execution methodology;
- iii) withdrawal from or repudiation/abandonment of the supply/services by the S eller before completion as per contract or if the Seller refuses or is unable to sup ply goods or materials covered by the order/Contract either in whole or in part or otherwise fails to perform the Order/Contract.
- iv) Non supply by the Seller within scheduled completion/delivery period as per contract or as extended from time to time for reasons attributable to the Seller;
- v) Termination of Contract on account of any other reason(s) attributable to the e Seller.
- vi) Assignment, transfer, sub-letting of Contract without BHEL's written permiss ion resulting in termination of Contract or part thereof by BHEL.
- vii) If the Seller be an individual or a Sole Proprietorship, in the event of death or insanity of the Seller.
- viii) If the Seller/Contractor being an individual or if a partnership firm thereof, sh

all at any time be adjudged insolvent or shall have a receiving order for administ ration of his estate made against him or shall take any proceeding for compositi on under any Insolvency Act for the time being in force or make any assignment of the order/Contract or enter into any arrangement or composition with his cred itors or suspend payment or if the firm dissolved under the Partnership Act;

- ix) If the Seller/Contractor being a Company is wound up voluntarily or by order of a Court or a Receiver, Liquidator or Manager on behalf of the debenture holde rs and creditors is appointed or circumstances have arisen which entitles the Co urt of debenture holder and creditors to appoint a receiver, liquidator or manage r:
- x) Non- Compliance to any contractual condition or any other default attribut able to the Seller.

Such defaulting vendor/Seller may not be eligible to participate in re-tendering conducted on account of purchase made due to fault / breach of contract by such vendor/Seller.

- 2) Penalty & Recovery on account of Purchases made by Purchaser on account of breach of contract of Seller/ Contractor shall be:
 - i) BHEL reserves the right to Encash / forfeit the availability securities, recover y from the available bills of the contractor, retention amount etc. of the same contract / other contracts if any to the extent of 10% of contract value. In case the available securities, bills, retention amount etc. is less than 10%, then BHEL reserves the right to pursue through legal remedies.

All questions and disputes/difference relating to the meaning of the specifications, design, drawings and instructions and or interpretation of the contract or its clauses and as to the quality of workmanship or materials used on the work or as to any other question, claim, ri ght, matter or thing whatsoever in any way arising out of or relating to the contract, desig ns, drawing, specifications, estimates, instructions, orders or these conditions or otherwise concerning the works or the execution or failure to execute the same whether arising duri ng the progress of the work or after the completion or abandonment thereof shall be referr ed to the Sole Arbitrator appointed by BHEL. BHEL will suggest three names, giving opport unity to contractor or vendor to choose one of them as sole arbitrator and in case parties c ould not mutually agree on the sole arbitrator, then the Arbitrator shall be appointed as pe r the provisions of Arbitration and Conciliation Act 1996 and any Amendments / modificatio n thereon and re-enactments thereof from time to time. The cases referred to arbitration s hall be other than those for which the decision of the Dy. General Manager / Sr. Manager /Project Manager/Manager/Sr. Engineer/Engineer, is expressed in the contract to be final a nd conclusive. The arbitrator to whom the matter is originally referred being unable to act f or any reason, another person to act as sole arbitrator shall be appointed in line with Arbitr ation and Conciliation Act 1996 and any Amendments / modification thereon and re-enact ments thereof from time to time and such person shall be entitled to proceed with the refer ence from the stage at which it was left by his predecessor.

Subject as aforesaid the provisions of the Arbitration and Conciliation Act, 1996 or any stat utory modification or re-enactment thereof and the rules made there under and for the time being in force shall apply to the arbitration proceedings.

It is a term of the contract that the party invoking arbitration shall specify the dispute or disputes including specifying the quantum of financial claim, if any, to be referred to arbitratio

n under this clause together with the amount or amounts claimed in respect of each such d ispute.

The arbitrator (s) shall complete the entire arbitration and publish an award within a perio d of twelve months from the date the Tribunal enters upon the reference.

The parties to this arbitration agreement may before or at the time of invoking the Arbitrat ion clause, may indicate in writing for FAST TRACK PROCEDURE wherein the Arbitrator shall pass an award within six months from the date the Tribunal enters upon the reference and to that effect, the Tribunal may dispense with any technical formalities and conduct the proceedings without oral hearing, subject to acceptance of such Fast Track procedure by o ther party.

The work under the Contract shall continue during the arbitration proceeding and no paym ent due to the Contractor shall be withheld on account of such proceedings.

The contract shall be governed by and construed in accordance with laws of India, without regards to any conflict of laws principles. The Venue and seat of arbitration shall be Bang alore and the language will be English only. The award of the arbitrator shall be final, conclusive and binding all parties to this contract.

Each party submits to the jurisdiction of Courts of Bengaluru for the purposes adjudicating any disputes or differences relating to this contract or arising out of this contract or compelling compliance with the above arbitration provisions and for enforcement of any arbitration award made in accordance with the above provisions.

3. Inspection

Nominated Inspection Agency: On behalf of the Buyer organization, any one of the following Inspection Agency would be conducting inspection of stores before acceptance: Pre-dispatch Inspection at Seller Premises (applicable only if pre-dispatch inspection clause has been selected in ATC):

Post Receipt Inspection at consignee site before acceptance of stores: Not Applicable

4. Inspection

Pre-dispatch inspection at Seller premises (Fee/Charges to be borne by the BUYER): Before dispatch, the goods will be inspected by Buyer / Consignee or their Authorized Representative or by Nominated External Inspection Agency (independently or jointly with Buyer or Consignee as decided by the Buyer) at Seller premises (or at designated place for inspection as declared / communicated by the seller) for their compliance to the contract specifications. Fee/Charges taken by the External inspection Agency and any external laboratories testing charges shall be borne by the Buyer. For in-house testing, the Sellers will provide necessary facilities free of cost. Seller shall notify the Buyer through e-mail about readiness of goods for pre-dispatch inspection and Buyer will notify the Seller about the Authorized Representative/ Nominated External Inspection Agency and the date for testing. The goods would be dispatched to consignee only after clearance in pre-dispatch inspection. Consignee's right of rejection as per GTC in respect of the goods finally received at his location shall in no way be limited or waived by reason of the goods having previously been inspected, tested and passed by Buyer/ Consignee or its Nominated External Inspection Agency prior to the goods' shipment. While bidding, the sellers should take into account 7 days for inspection from the date of email offering the goods for inspection. Any delay in inspection beyond 7 days shall be on the part of the buyer and shall be regularised without Liquidated Damages.

When there is requirement of submission the advance sample, the seller shall inform the buyer promptly through emails about the date of submission of sample to the buyer nominated Inspection agency.

8. Generic

- 1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- 2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-
