If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. 1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- **1a) Qualifying Criteria [Previous Work]:** The vendor should have supplied Smoke detection and Fire al arm system in the last Five years from the date of enquiry. Supplier should submit at least one PO copy for the same.
- **1b) Relaxation of Norms for Startups:** The condition of Prior Turnover and prior experience is relaxed f or all startups whether Micro & Small Enterprises(MSEs) or otherwise subject to meeting of quality and tec hnical specifications in accordance with the relevant provision of GFR,2005 and other DOE-PPD notification s for relaxation norms for start-ups issued from time to time.
- **2) Payment term:** 80% payment of the supply value shall be made within 15 days from the date of recei pt of material with clear documents at BHEL. Balance 20% of supply value plus 100% of the E&C portion of PO Value will be paid against E&C certificate issued by BHEL and submission of Performance Bank Guarant ee by supplier.

However, GST Portion of Invoice shall be released only upon:

- i) Vendor declaring the Invoice in their GSTR-1.
- ii) Receipt of Goods and Tax Invoice by BHEL.
- iii) Confirmation of Payment of GST thereon by vendor on GSTN.

3)Performance Bank guarantee (PBG): PBG of 10% of total order value is to be submitted by the succ essful vendor and shall be kept valid up to guarantee period with additional claim period of 3-6 months the reafter. PBG shall be from one of the Consortium banks of BHEL or from a reputed bank and confirmed by any Consortium bank of BHEL. The offers of the suppliers not accepting to this clause will be rejected.

Note: Format of Performance Bank guarantee (PBG) is attached in Buyer added Bid Specific Additional Sco pe of Work.

- **4) Interest of delayed submission of PBG:** Bidder agrees to submit performance bank guarantee (PBG) in the prescribed format with-in 15 days from the date of completion of commissioning. In case of delay in submission of PBG, enhanced performance security which would include interest (SBI rate + 6%) for the delayed period, shall be submitted by the bidder. Further, if performance security is not submitted till such time the first bill becomes due, the amount of performance security due shall be recovered as per terms defined in NIT/contract, from the bills along with due interest.
- **5) Warranty clause:** The vendor should provide warranty for a period of 1 year from the date of E&C (erection an d commissioning) and acceptance of smoke detection and Fire alarm system at BHEL R&D.

(This clause supersedes the warranty clause mentioned in item specifications.)

- 6) Vendor has to submit this GeM bid document duly signed and stamped on all pages. By submitting sign ed GeM bid document it affirms that vendor has accepted to all the terms and conditions mentioned in this bid such as Specifications, Payment terms, delivery period etc.
- 7) Vendor has to quote price(s) inclusive of GST and transportation charges, if any.
- **8) Breach of contract, Remedies and Termination:** In case of breach of contract, wherever the value of security instruments like performance bank guarantee available with BHEL against the said contract is a tleast 10% of the contract value, the same be encashed. In case the value of the security instruments avail able is less than 10% of the contract value, the balance amount be recovered from other financial remedies (i.e. available bills of the contractor, retention amount, etc. with BHEL) or legal remedies be pursued.

Further, levy of liquidated damages, debarment, termination, de-scoping, short-closure, etc., shall be appli ed as per provisions of the contract.

- **9) Delivery period:** The delivery period 158 days (from PO) is for complete scope i.e. Supply, Erection a nd commissioning. Schedule for each activity is as mentioned below:
- i) Supply: Material are to be delivered preferably within 98 days from the date of P.O.
- **ii) Erection and commissioning:** Vendor to complete erection and commissioning activities within 30 d ays from the date of receipt of line of clearance from BHEL. BHEL will furnish the line of clearance for commissioning within 30 days from date of receipt and acceptance of material at BHEL

10) Penalty for Delay in supply and commissioning:

- 10a) For the purpose of penalty for delay in commissioning of the Smoke Detection and Fire Alarm system the duration will be reckoned from the date of intimation by BHEL to vendor for readiness of site.
- 10b) Penalty on delay in 'Supply' and/or 'commissioning 'will be applicable to the delays attributed to ven dor.

Penalty will be considered separately for 'Supply' and 'commissioning'.

The rate of penalty for delayed Supply shall be @ 0.5% per week of delay of total PO value (Supply+ Commissioning) in supply subject to a maximum of 10% of total PO value (Supply+ commissioning).

The rate penalty for delayed commissioning shall be @0.5% per week of delay of total PO Value (Supply+commissioning) in commissioning subject to a maximum of 10% of total PO value (Supply+commissioning). Maximum penalty for delay in Supply and commissioning together shall be limited to 15% of total PO value (Supply+commissioning).

10C) Incase, any shortage is noticed viz-a-viz PO requirement in the main Smoke Detection and Fire Alarm system, such shortages shall be replenished by supplier on for destination basis without any cost implicati on to BHEL i.e. Custom Duty and freight charges etc. up to destination for such short supplies shall be bor ne by the supplier.

- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
