OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

#### 1) Pre-Qualification Criteria:

##### Vendor shall produce supporting documents for the following:

**1a)** Vendor must have supplied at least one Workstation/Server with minimum 128GB RAM in last 5 years from the date of enquiry. Vendor shall submit PO copy in support of the same.

**1b)** Authorization from OEM to Bidder to participate in the tender

**1c)** The condition of Prior Turnover and prior experience is relaxed for all start-ups whether Micro & Small Enterprises(MSEs) or otherwise subject to meeting of quality and technical specifications in accordance with the relevant provision of GFR,2005 and other DOE-PPD notifications for relaxation norms for start-ups issued from time to time.

**2) Payment term:** 100% payment shall be made within stipulated days as mentioned below from the date of installation & commissioning, demonstration and acceptance at BHEL R&D and submission of Performance Bank Guarantee (PBG) by supplier in the prescribed format.

#### Type of bidder:

B. For Medium Enterprises will be made within 60 days

C. Non MSMEs will be made within 90 days However, GST Portion of Invoice shall be released only upon:

**3) Performance Bank Guarantee (PBG):** PBG of 10% of total order value is to be submitted by the successful vendor and shall be kept valid up to guarantee/warranty period with additional claim period of 3-6 months thereafter. **4) Interest for delayed submission of performance security (PBG):** PBG of 10% of total order value is to be submitted by the successful vendor within 15 days from the date of completion of entire scope. Bidder agrees to submit performance security required for execution of the contract within the time period

mentioned. In case of delay in submission of performance security, enhanced performance security which would include interest (Repo rate + 4%) for the delayed period, shall be submitted by the bidder. Further, if performance security is not submitted till such time the first bill becomes due, the amount of performance security due shall be recovered as per terms defined in NIT/contract, from the bills along with due interest.

**5) Restriction:** Submit the Annexure - A which is attached in Page 1 of Buyer uploaded ATC document.

**6) Delivery period:** The delivery period 60 days (from PO date) is for complete scope i.e. Supply, installation / Commissioning and demonstration.

**7) Vendor** has to submit this GeM bid document duly signed and stamped on all pages. By submitting signed GeM bid document it affirms that vendor has accepted to all the terms and conditions mentioned in this bid such as Payment terms, PBG, delivery period etc.

**8) Vendor** has to quote prices inclusive of GST and other applicable charges.

**9) Breach of contract, Remedies and Termination:**

In case of breach of contract, wherever the value of security instruments like performance bank guarantee available with BHEL against the said contract is at least 10% of the contract value, the same be encashed. In case the value of the security instruments available is less than 10% of the contract value, the balance amount be recovered from other financial remedies (i.e. available bills of the contractor, retention amount, etc. with BHEL) or legal remedies be pursued. Further, levy of liquidated damages, debarment, termination, de-scoping, short-closure, etc., shall be applied as per provisions of the contract.
