1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. 2. Generic

a. <u>General:</u>

The specification covers the design, materials construction features, manufacture and testing of v alves at vendor's / sub vendor's works inclusive of painting and packing requirements. The valves shall meet the technical requirements and conform to the data sheet The valves complete with all accessories shall be supplied as per data sheet. For details refer the same.

b. Codes & Standards:

The design, materials, construction features, manufacture, inspection and testing of the valves sh all conform to the latest applicable codes & standards.

c. <u>Design Requirements</u>:

The valves shall be used for non-corrosive media like compressed air piping, cooling water service etc and shall be of non-fire safe design.
