Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. 2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

# 1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

**1a) Pre-Qualifying Criteria:** Supplier should have supplied LED Light Fittings in the last 5 years from the date of enquiry. As a proof of this supplier shall be required to submit copy of at least one purchase order f or the same.

- **1b) Relaxation of Norms for Startups:** The condition of Prior Turnover and prior experience is relaxed f or all startups whether Micro & Small Enterprises(MSEs) or otherwise subject to meeting of quality and tec hnical specifications in accordance with the relevant provision of GFR,2005 and other DOE-PPD notification s for relaxation norms for start-ups issued from time to time.
- **2) Payment term:** 100% payment shall be made within the stipulated days as mentioned below from the date of receipt and acceptance of materials at BHEL Corporate R&D Vikasnagar, Hyderabad

Type of bidder:

- A. For Micro & Small enterprises(MSEs) payment will be made within 45 days
- B. For Medium Enterprises will be made within 60 days
- C. Non MSMEs will be made within 90 days

However, GST Portion of Invoice shall be released only upon:

- i) vendor declaring the Invoice in their GSTR-1.
- ii) Receipt of Goods and Tax Invoice by BHEL.
- iii) Confirmation of Payment of GST thereon by vendor on GSTN.
- 3) Vendor has to submit this GeM bid document duly signed and stamped on all pages. By submitting sign ed GeM bid document it affirms that vendor has accepted to all the terms and conditions mentioned in this bid such as Specifications, Payment terms, delivery period etc.
- 4) Vendor has to quote price(s) inclusive of GST and transportation charges, if any.
- **5) Breach of contract, Remedies and Termination:** In case of breach of contract, wherever the value of security instruments like performance bank guarantee available with BHEL against the said contract is a tleast 10% of the contract value, the same be encashed. In case the value of the security instruments avail able is less than 10% of the contract value, the balance amount be recovered from other financial remedies (i.e. available bills of the contractor, retention amount, etc. with BHEL) or legal remedies be pursued.

Further, levy of liquidated damages, debarment, termination, de-scoping, short-closure, etc., shall be applied as per provisions of the contract.

- 8. Seeking sample with bid or approval of samples during bid evaluation process.

- 11. Creating bid for items from irrelevant categories.

- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
