6. 7. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

7. **Purchase Preference (Centre)**

3. Vendor to comply all T&C as per NIT/Tender terms.
4. Estimated Bid Value shown is including GST of 18%.
5. Bidders are requested to read and understand the BOQ, Scope and other NIT Terms carefully before quoting.
