- 1. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry o Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bic wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid fo supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 OM_No.1_4_2021_PPD_dated_18.05.2023 for compliance of Concurrent applica of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Mak India) Order, 2017.
- 2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which wo be determined by the buyer based on its own assessment of reasonableness and based on competitive prices receiv in Bid / RA process.
- 3. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidders.

The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracter rates. Bidders are bound to accept the orders accordingly.

12. Risk Purchase:

In case of abnormal delays (beyond the maximum late delivery period as per LD clause) in supplies / defectiv pplies or non-fulfilment of any other terms and conditions given in Purchase Order, BHEL may cancel the Purchase of rolling or part thereof, and may also make the purchase of such material from elsewhere / alternative ce at the risk and cost of the supplier. BHEL will take all reasonable steps to get the material from alternate so e at optimum cost. If bidder does not agree to the above Risk Purchase Clause, BHEL reserves the right to rejude offer. In case for compelling reasons BHEL accepts the offer without acceptance of this clause by the bidded in the eventuality of Risk Purchase, appropriate action will be taken as per BHEL extant rules. This will be well the prejudice to any other right of BHEL under the contract or under General Law

13. Action against Bidders / vendor / supplier / contractor in case of default:

In order to protect the commercial interests of BHEL, BHEL shall take action against supplies / contractors by of suspension of business dealings, who either fail to perform or are in default without any reasonable cause, se loss of business/ money/ reputation, indulge in malpractices, cheating, bribery, fraud or any other misconc or formation of cartels so as to influence the bidding process or influence the price etc.

Suspension of Business Dealings could be in the form of "Hold" or "Banning" a supplier/ contractor or a bidde d shall be as per "Guidelines for Suspension of Business Dealings with Suppliers/ Contractors" available at BH website "https://www.bhel.com/guidelines-suspension-business-dealings-supplierscontractors"

14. Conflict of Interest:

"A bidder shall not have conflict of interest with other bidders. Such conflict of interest can lead to anticompe e practices to the detriment of Procuring Entity's interests. The bidder found to have a

conflict of interest shall be disqualified. A bidder may be considered to have a conflict of interest with one or more parties in this bidding process, if:

- a) they have controlling partner (s) in common; or
- b) they receive or have received any direct or indirect subsidy/ financial stake from any of them; or
- c) they have the same legal representative/agent for purposes of this bid; or
- d) they have relationship with each other, directly or through common third parties, that puts ther a position to have access to information about or influence on the bid of another Bidder; or
- e) Bidder participates in more than one bid in this bidding process. Participation by a Bidder in mor an one Bid will result in the disqualification of all bids in which the parties are involved. However, does not limit the inclusion of the components/ sub-assembly/ Assemblies from. one bidding manurer in more than one bid; or
- f) In cases of agents quoting in offshore procurements, on behalf of their principal manufacturers, agent cannot represent two manufacturers or quote on their behalf in a particular tender enquiry. manufacturer can also authorise only one agent/dealer. There can be only one bid from the following
 - 1. The principal manufacturer directly or through one Indian agent on his behalf; and
 - 2. Indian/foreign agent on behalf of only one principal; or
- g) A Bidder or any of its affiliates participated as a consultant in the preparation of the design or te cal specifications of the contract that is the subject of the Bid, \cdot or
- h) In case of a holding company having more than one independently manufacturing units, or more n one unit having common business ownership/management, only one unit should quote. Similar rections would apply to closely related sister companies. Bidders must proactively declare such sister ommon business/ management units in same/ similar line of business."

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.

- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case m be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to r to all such representations and would not be allowed to open bids if he fails to reply to such representations.
