Performance security is to be furnished by 14 days after date of PO and it should rem ain valid for a period of 60 days beyond the date of completion of all contractual obligations of the supplier, including warranty obligations.

Performance security may be furnished in the following forms:

- (i) Local cheques of Scheduled Banks (subject to realization)/ Pay Order/Demand Draft/ Electronic Fund Transfer in favour of BHEL.
- (ii) Bank Guarantee from Scheduled Banks / Public Financial Institutions as defined in the Companies Act. The Bank Guarantee format should have the approval of BHEL.
- (iii) Fixed Deposit Receipt issued by Scheduled Banks / Public Financial Institutions as defined in the Companies Act (FDR should be in the name of the Contractor, a/c BHEL ).
- (iv) Securities available from Indian Post offices such as National Savings Certificates, Kisan Vikas Patras etc. (held in the name of Contractor furnishing the security and duly endorsed/ hypothecated/ pledged, as applicable, in favour of BHEL).
- (v) Insurance Surety Bond.

(Note: BHEL will not be liable or responsible in any manner for the collection of intere st or renewal of the documents or in any other matter connected therewith)

## **Forfeiture of Performance Security**

The performance security will be forfeited and credited to BHEL's account in the eve nt of a breach of contract by the supplier. The Performance Security shall not carry a ny interest.

14. Payment terms shall be as per followings:

### For Non MSEs bidder:

100% payment along with taxes, freight & insurance will be made after receipt and accept ance of material and within 90 days from the date of invoice subject to submission of non-d iscrepant documents within 15 days of supply as per terms and conditions of Purchase Ord er.

#### For MSEs bidder:

For MSEs (covered under MSME Act) which are registered and periodically renewed with BH EL, the payment will be made within 45 days or as prescribed in the relevant act. Benefits o f MSE (such as EMD Waiver, Tender fee exemption, Price preference, Payment preference e tc.) will be given only to those MSE Vendors who are manufacturers of offered items agains t the NIT. No MSE benefits shall be provided to Agents / Stockists / Dealers / Traders etc. for the items offered but not manufactured by themselves."

## For Medium Enterprises:

100% payment along with taxes, freight & insurance will be made after receipt and accept ance of material and within 60 days from the date of invoice subject to submission of non-d iscrepant documents within 15 days of supply as per terms and conditions of Purchase Ord er.

#### 15.Risk Purchase:

In case of abnormal delays (beyond the maximum late delivery period as per LD clause) in supplies / defective supplies or non-fulfillment of any other terms and conditions given in P urchase Order, BHEL may cancel the Purchase Order in full or part thereof, and may also m ake the purchase of such material from elsewhere / alternative source at the risk and cost o f the supplier. BHEL will take all reasonable steps to get the material from alternate source at optimum cost. If bidder does not agree to the above Risk Purchase Clause, BHEL reserve s the right to reject the offer. In case for compelling reasons BHEL accepts the offer without acceptance of this clause by the bidder and in the eventuality of Risk Purchase, appropriate action will be taken as per BHEL extant rules. This will be without prejudice to any other right of BHEL under the contract or under General Law

## Action against Bidders / vendor / supplier / contractor in case of default:

In order to protect the commercial interests of BHEL, BHEL shall take action against supplie s / contractors by way of suspension of business dealings, who either fail to perform or are in default without any reasonable cause, cause loss of business/ money/ reputation, indulge in malpractices, cheating, bribery, fraud or any other misconduct or formation of cartels so as to influence the bidding process or influence the price etc.

- 1.0 Integrity commitment, performance of the contract and punitive action thereof:
- 1.1. Commitment by BHEL: BHEL commits to take all measures necessary to prevent corruption in connection with the tender process and execution of the contract. BHEL will during

the tender process treat all Bidder(s) in a transparent and fair manner, and with equity.

- 1.2. Commitment by Bidder/ Supplier/ Contractor:
- 1.2.1. The bidder/ supplier/ contractor commits to take all measures to prevent corruption a nd will not directly or indirectly influence any decision or benefit which he is not legally entitled to nor will act or omit in any manner which tantamount to an offence punishable under any provision of the Indian Penal Code, 1860 or any other law in force in India.
- 1.2.2. The bidder/ supplier/ contractor will, when presenting his bid, disclose any and all pa yments he has made, and is committed to or intends to make to agents, brokers or any oth er intermediaries in connection with the award of the contract and shall adhere to relevant guidelines issued from time to time by Govt. of India/ BHEL.
- 1.2.3. The bidder/ supplier/ contractor will perform/ execute the contract as per the contract t terms & conditions and will not default without any reasonable cause, which causes loss of business/ money/ reputation, to BHEL.

If any bidder/ supplier/ contractor during pre-tendering/ tendering/ post tendering/ award/ e xecution/ post-execution stage indulges in malpractices, cheating, bribery, fraud or and oth er misconduct or formation of cartel so as to influence the bidding process or influence the price or acts or omits in any manner which tantamount to an offence punishable under any provision of the Indian Penal Code, 1860 or any other law in force in India, then, action may be taken against such bidder/ supplier/ contractor as per extant guidelines of the company available on www. bhel.com and/or under applicable legal provisions.

#### 16. Conflict of Interest:

"A bidder shall not have conflict of interest with other bidders. Such conflict of intere st can lead to anti-competitive practices to the detriment of Procuring Entity's interes ts. The bidder found to have a conflict of interest shall be disqualified. A bidder may be considered to have a conflict of interest with one or more parties in this bidding process, if:

- a) they have controlling partner (s) in common; or
- b) they receive or have received any direct or indirect subsidy/ financial stake from a ny of them; or
- c) they have the same legal representative/agent for purposes of this bid; or
- d) they have relationship with each other, directly or through common third parties, t hat puts them in a position to have access to information about or influence on the bi d of another Bidder: or
- e) Bidder participates in more than one bid in this bidding process. Participation by a Bidder in more than one Bid will result in the disqualification of all bids in which the p arties are involved. However, this does not limit the inclusion of the components/ sub -assembly/ Assemblies from one bidding manufacturer in more than one bid; or
- f) In cases of agents quoting in offshore procurements, on behalf of their principal ma nufacturers, one agent cannot represent two manufacturers or quote on their behalf i n a particular tender enquiry. One manufacturer can also authorize only one agent/d ealer. There can be only one bid from the following:

- 1. The principal manufacturer directly or through one Indian agent on his behalf; a
  - 2. Indian/foreign agent on behalf of only one principal;

or

- g) A Bidder or any of its affiliates participated as a consultant in the preparation of the design or technical specifications of the contract that is the subject of the Bid, or
- h) In case of a holding company having more than one independently manufacturing units, or more than one unit having common business ownership/management, only one unit should guote. Similar restrictions would

apply to closely related sister companies. Bidders must proactively declare such siste r/ common business/ management units in same/ similar line of business. "
