Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. #### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

### 2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

### 3. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- a. Copy of PAN Card.
- b. Copy of GSTIN.
- c. Copy of Cancelled Cheque.
- d. Copy of EFT Mandate duly certified by Bank.

#### 4. Generic

Consortium: In case of Contracts, wherein the seller alone does not have necessary expertise, the seller can form consortium with other sellers for submission of the bid, with one of the consortium company as leader. However, each and every member of the consortium shall be equally responsible for the complete execution of the project contract. An undertaking to this effect is to be uploaded with bid.

# 7. Generic

- 1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buye

### 8. Generic

- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchas Order on the Seller.

### 9. Generic

While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

### 15. Conflict of Interest:

"A bidder shall not have conflict of interest with other bidders. Such conflict of in terest can lead to anti-competitive practices to the detriment of Procuring Entity 's interests. **The bidder found to have a conflict of interest shall be disqu alified**. A bidder may be considered to have a conflict of interest with one or m ore parties in this bidding process, if:

i) they have controlling partner (s) in common;

or

 ii) they receive or have received any direct or indirect subsidy/ financial st ake from any of them;

or

iii) they have the same legal representative/agent for purposes of this bid;

or

iv) they have relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the bid of another Bidder;

or

v) Bidder participates in more than one bid in this bidding process. P articipation by a Bidder in more than one Bid will result in the disqual ification of all bids in which the parties are involved. However, this do es not limit the inclusion of the components/ sub-assembly/ Assembli es from. one bidding manufacturer in more than one bid;

or

- vi) In cases of agents quoting in offshore procurements, on behalf of t heir principal manufacturers, one agent cannot represent two manuf acturers or quote on their behalf in a particular tender enquiry. One manufacturer can also authorize only one agent/dealer. There can be only one bid from the following:
  - 1. The principal manufacturer directly or through one Indian age

nt on his behalf; and

Indian/foreign agent on behalf of only one principal;

vii) A Bidder or any of its affiliates participated as a consultant in the p reparation of the design or technical specifications of the contract that is the subject of the Bid;

# **16.** Risk Purchase:

In case of abnormal delays (beyond the maximum late delivery period as per LD clause) in supplies / defective supplies or non-fulfillment of any other terms and conditions given in Purchase Order, BHEL may cancel the Purchase Order in full or part thereof, and may also make the purchase of such material from elsewher e / alternative source at the risk and cost of the supplier. BHEL will take all reaso nable steps to get the material from alternate source at optimum cost. If bidder does not agree to the above Risk Purchase Clause, BHEL reserves the right to reject the offer. In case for compelling reasons BHEL accepts the offer without acceptance of this clause by the bidder and in the eventuality of Risk Purchase, appropriate action will be taken as per BHEL extant rules. This will be without prejudice to any other right of BHEL under the contract or under General Law.
