Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. 1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- **1a) Pre Qualification Criteria [Eligibility]:** Bidder to submit at least one PO copy for CCTV system which should be within last Five years from the date of enquiry.
- **1b) Relaxation of Norms for Startups:** The condition of Prior Turnover and prior experience is relaxed f or all startups whether Micro & Small Enterprises(MSEs) or otherwise subject to meeting of quality and tec hnical specifications in accordance with the relevant provision of GFR,2005 and other DOE-PPD notification s for relaxation norms for start-ups issued from time to time.
- **2) Payment term:** 80% payment of the supply value shall be made within 15 days from the date of recei pt of material with clear documents at BHEL. Balance 20% of supply value plus 100% of the E&C portion of PO Value will be paid against E&C certificate issued by BHEL and submission of Performance Bank Guarant ee by supplier.

However, GST Portion of Invoice shall be released only upon:

- i) Vendor declaring the Invoice in their GSTR-1.
- ii) Receipt of Goods and Tax Invoice by BHEL.
- iii) Confirmation of Payment of GST thereon by vendor on GSTN.
- **3)Performance Bank guarantee (PBG):** PBG of 10% of total order value is to be submitted by the succ essful vendor and shall be kept valid up to guarantee period with additional claim period of 3-6 months the reafter. PBG shall be from one of the Consortium banks of BHEL or from a reputed bank and confirmed by

any Consortium bank of BHEL. The offers of the suppliers not accepting to this clause will be rejected.

Note: Format of Performance Bank guarantee (PBG) is attached in Buyer added Bid Specific Additional Scope of Work.

- **4) Interest of delayed submission of PBG:** Bidder agrees to submit performance bank guarantee (PBG) in the prescribed format with-in 15 days from the date of completion of commissioning. In case of delay in submission of PBG, enhanced performance security which would include interest (Reporate + 4%) for the delayed period, shall be submitted by the bidder. Further, if performance security is not submitted till such time the first bill becomes due, the amount of performance security due shall be recovered as per terms defined in NIT/contract, from the bills along with due interest.
- 5) Vendor has to submit this GeM bid document duly signed and stamped on all pages. By submitting sign ed GeM bid document it affirms that vendor has accepted to all the terms and conditions mentioned in this bid such as Payment terms, PBG, delivery period and Penalty for Delay etc.
- 6) Vendor has to quote price(s) inclusive of GST and transportation charges, if any.
- **7) Breach of contract, Remedies and Termination:** In case of breach of contract, wherever the value of security instruments like performance bank guarantee available with BHEL against the said contract is a tleast 10% of the contract value, the same be encashed. In case the value of the security instruments avail able is less than 10% of the contract value, the balance amount be recovered from other financial remedies (i.e. available bills of the contractor, retention amount, etc. with BHEL) or legal remedies be pursued.

Further, levy of liquidated damages, debarment, termination, de-scoping, short-closure, etc., shall be appli ed as per provisions of the contract.

- **8) Delivery period:** The delivery period 70 days (from PO) is for complete scope i.e. Supply, Installation/c ommissioning and testing . Schedule for each activity is as mentioned below:
- i) Supply: Material are to be delivered within 6 weeks from the date of P.O.
- ii) Installation/commissioning and testing: Vendor to complete Installation and Testing activities within 4 w eeks from the date of receipt of material at BHEL R & D.

BHEL site is ready, hence installation work can be started from date of receipt of material at BHEL R & D.

9) Penalty for Delay in supply and commissioning:

- 9a) For the purpose of penalty for delay in installation/ commissioning of the network system, the duration will be reckoned from the date of receipt of material at BHEL R & D as site is ready for installation work.
- 9b) Penalty on delay in 'Supply' and/or 'commissioning/Installation' will be applicable to the delays attribut ed to vendor.

Penalty will be considered separately for 'Supply' and 'commissioning'.

The rate of penalty for delayed Supply shall be @ 0.5% per week of delay of total PO value (Supply+ Commissioning) in supply subject to a maximum of 10% of total PO value (Supply+ commissioning).

The rate penalty for delayed commissioning shall be @0.5% per week of delay of total PO Value (Supply + commissioning) in commissioning subject to a maximum of 10% of total PO value (Supply + commissioning). Maximum penalty for delay in Supply and commissioning together shall be limited to 15 % of total PO v alue (Supply+ commissioning).

- 9c) Incase, any shortage is noticed viz-a-viz PO requirement in the main CCTV system, such shortages shall be replenished by supplier on for destination basis without any cost implication to BHEL i.e. Custom Duty and freight charges etc. up to destination for such short supplies shall be borne by the supplier.
- **10) Compliance on Restrictions under rule 144 (xi) of the GFR:** Please Submit the Annexure A (on supplier s letter head) which is attached in ATC document.
