Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.

Description: Laptop / Mobile Workstation

1) Pre-Qualification Criteria:

- **1a)** Bidder shall submit at least one Purchase order copy for Laptop/ Mobile workstation, which should be within last 5 years from the date of this enquiry.
- **1b)** Relaxation of Norms for Start-ups: The condition of Prior Turnover and prior experience is relaxed for al I start-ups whether Micro & Small Enterprises(MSEs) or otherwise subject to meeting of quality and technic al specifications in accordance with the relevant provision of GFR,2005 and other DOE-PPD notifications for relaxation norms for start-ups issued from time to time.
- **2) Payment term:** 100% basic payment shall be made within stipulated days as mentioned below from t he date of receipt and acceptance of material at BHEL Corporate R&D, Hyderabad and submission of Performance Bank Guarantee (PBG) by supplier in the prescribed format.

Type of bidder:

- A. For Micro & Small enterprises(MSEs) payment will be made within 45 days
- B. For Medium Enterprises will be made within 60 days
- C. Non MSMEs will be made within 90 days However, GST Portion of Invoice shall be released only upon:
- i) Vendor declaring the Invoice in their GSTR-1.
- ii) Receipt of Goods and Tax Invoice by BHEL.
- iii) Confirmation of Payment of GST thereon by vendor on GSTN.
- **3) Performance Bank Guarantee (PBG):** PBG of 10% of total order value is to be submitted by the succ essful vendor and shall be kept valid up to guarantee/warranty period with additional claim period of 3-6 months thereafter. The offers of the suppliers not accepting to this clause will be rejected.

Note: Pro-forma of Performance Bank Guarantee is attached in ATC document.

4) Interest for delayed submission of performance security (PBG): PBG of 10% of total order value is to be submitted by the successful vendor within 15 days from the date of receipt and acceptance of mat

erial at BHEL Corporate R&D. Bidder agrees to submit performance security required for execution of the c ontract within the time period mentioned. In case of delay in submission of performance security, enhance d performance security which would include interest (Repo rate + 4%) for the delayed period, shall be sub mitted by the bidder. Further, if performance security is not submitted till such time the first bill becomes due, the amount of performance security due shall be recovered as per terms defined in NIT/contract, from the bills along with due interest.

- **5) Restriction:** Submit the Annexure A which is attached in ATC document.
- **6) Technical Specification:** Bidder shall submit compliance on attached BHEL Technical specification (A nnexure-1) uploaded in Buyer Specification Document
- 7) **Delivery period:** The delivery period is 70 days from PO date
- **8)** Vendor has to submit this GeM bid document duly signed and stamped on all pages. By submitting sing ed Gem bid document it affirms that vendor has accepted to all terms and conditions mentioned in this bid such as payment terms, performance guarantee, Interest for delayed submission of performance security (PBG), delivery period etc.
- 9) Terms of Delivery: Shall be FOR BHEL R&D Stores, Hyderabad.
- **10)** Vendor has to quote prices inclusive of GST and other applicable charges.

11) Breach of contract, Remedies and Termination:

In case of breach of contract, wherever the value of security instruments like performance bank guarantee available with BHEL against the said contract is atleast 10% of the contract value, the same be encashed. In case the value of the security instruments available is less than 10% of the contract value, the balance a mount be recovered from other financial remedies (i.e. available bills of the contractor, retention amount, etc. with BHEL) or legal remedies be pursued. Further, levy of liquidated damages, debarment, termination, de-scoping, short-closure, etc., shall be applied as per provisions of the contract.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
