1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. 

- 20) <u>Test Report</u>: Supplier shall submit Test report / Compliance report for all the above mentioned features indicating serial number of the PS module & date of test.
- 21) **Type Test Certificate**: Type Test certificates for the PS model being supplied & conducted in a Govt Approved/Accredited Lab & valid within the last five years shall be submitted along with offer to enable technical evaluation.

 - 23) **Approvals:** The Power Supply Unit shall have the required CE/UL certification
- 24) <u>Catalogue</u>: Supplier to submit catalogue / performance curves for the model being offered
 - Efficiency Vs load,
 - Op.Temperature Vs Load Current etc
- 25) Each power supply module should be marked with SLNO, BATCH NUMBER AND MONTH OF MANUFACTURING for easy identification.
- 26) **<u>Deviation</u>**: Offer shall include columns in tabular form having BHEL clause-wise specification number, technical requirement as per BHEL specification, technical parameters offered by vendor, deviations against each sub-clause if applicable amongst other data.
