

1. Bidders are required to be Original Equipment Manufacturer (OEM) / Authorized Distributor of OEM / General Dealer. General Dealer should procure the item directly either from Authorized Distributor or OEM.

- 2. Documents to be submitted along with the technical bid:

 - b) General Dealers: Compliance to point 3(c)
- 3. Documents to be submitted during material supply:

- 6. **If the item quoted is supplied for the first time to BHEL,** after PQR clearance bidder to provide two sample models within two weeks of BHEL intimation and same shall be evaluated by BHEL as per technical specification submitted with this tender, Bidder to confirm supply of two samples on non-returnable basis.
- 7. If there are any queries regarding specification, it is bidder's responsibility to get the same clarified from the purchaser before submitting the offer.
- 8. On receipt at purchaser's works, if it is observed that the item requires rework / rectification, supplier shall arrange for the same at EDN works, Bangalore within 6 working days without any cost implications.
