Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 1. Buyer Added Bid Specific ATC

1a) Pre-Qualification Criteria : The bidder shall submit Purchase order copy for supply of at least one pump (of any kind) of 2HP or above received in last Three (03) years prior to this tender enquiry date.

1b) Relaxation of Norms for Startups: The condition of Prior Turnover and prior experience is relaxed for all startups whether Micro & Small Enterprises(MSEs) or otherwise subject to meeting of quality and technical specifications in accordance with the relevant provision of GFR,2005 and other DOE-PPD notifications for relaxation norms for startups issued from time to time.

2) Payment term: 100% payment shall be made within the stipulated days as mentioned below from the date of acceptance of Items/materials at BHEL Corporate R&D Vikasnagar, Hyderabad and submission of PBG by vendor in prescribed format.

In case of delay in submission of PBG enhanced amount which would include (Repo rate + 4%) for the delayed period shall be submitted by the bidder. Further if PBG is not submitted till that time the first bill comes due, the amount of PBG due shall be recovered as per terms defined in the NIT/contract from the bills along with due interest.
