Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bic for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

Description: "Workstation (Simulation Server)".

1) Pre-Qualification Criteria:

1a) The Bidder shall submit at least one purchase order copy for supply of workstation with minimum 64 GB RAM in the last 5 years from the date of enquiry.

1b) **Relaxation of Norms for Startups**: The condition of Prior Turnover and prior experience is relaxed for all startups whether Micro & Small Enterprises (MSEs) or otherwise subject to meeting of quality and technical specifications in accordance with the relevant provision of GFR,2005 and other DOE-PPD notifications for relaxation norms for startups issued from time to time.

2) Payment term:

100% basic payment shall be made within stipulated days as mentioned below from the date of com pletion of entire scope (i.e. Supply, installation, commissioning, demonstration and acceptance at BH EL R&D) and issue of Installation certificate by BHEL R&D Hyderabad and submission of Performance Bank Guarantee (PBG).

Type of bidder:

- A. For Micro & Small enterprises(MSEs) payment will be made with in 45 days
- B. For Medium Enterprises will be made with in 60 days
- C. Non MSMEs will be made with in 90 days

However, GST Portion of Invoice shall be released only upon:

- i) Vendor declaring the Invoice in their GSTR-1.
- ii) Receipt of Goods and Tax Invoice by BHEL.
- iii) Confirmation of Payment of GST thereon by vendor on GSTN
- 3) Restriction: Submit the Annexure A which is attached in ATC document.
- **4)** Bidder shall submit compliance on attached BHEL Technical specification (Annexure-1) uploaded in B uyer Specification Document
- **5) Terms of Delivery :** Shall be F.O.R BHEL Corp R&D Stores, Hyderabad.

6) Delivery period : The total delivery period is 150 days from PO date is for complete scope (i.e. Supply, installation, commissioning, demonstration).

Schedule for each activity is as mentioned below:

- i) Supply: Item to be delivered within 120 weeks from the date of P.O.
- ii) Installation, Commissioning and demonstration: Vendor to complete Installation, Commissioning and d emonstration activities within 30 days from the date of receipt & acceptance of item at BHEL R & D.

BHEL site is ready, hence installation work can be started from date of receipt of item at BHEL R & D.

- **7)** Vendor has to submit this GeM bid document duly signed and stamped on all pages. By submitting sig ned GeM bid document it affirms that vendor has accepted to all the terms and conditions mentioned in this bid such as Payment terms, delivery period etc.
- 8) Vendor has to quote prices inclusive of GST and other applicable charges.
- **9) Breach of contract, Remedies and Termination:** In case of breach of contract, wherever the value of security instruments like performance bank guarantee available with BHEL against the said cont ract is atleast 10% of the contract value, the same be encashed. In case the value of the security instrum ents available is less than 10% of the contract value, the balance amount be recovered from other financ ial remedies (i.e. available bills of the contract or, retention amount, etc. with BHEL) or legal remedies be pursued. Further, levy of liquidated damages, debarment, termination, de scoping, short-closure, etc., sh all be applied as per provisions of the contract.
- **10) Performance Bank Guarantee (PBG) :** PBG of 10% of total order value is to be submitted by the successful vendor and shall be kept valid up to guarantee period with additional claim period of 3-6 mont hs thereafter. PBG shall be from one of the Consortium banks of BHEL or from a reputed bank and confir med by any Consortium bank of BHEL. The offers of the suppliers not accepting to this clause will be rejected.

Note: Format of Performance Bank guarantee (PBG) is attached ATC document (Annexure-B).

11) Interest of delayed submission of PBG : Bidder has to submit performance bank guarantee (PB G) with-in 15 days date of completion of entire scope.

In case of delay in submission of PBG, enhanced performance security which would include interest (Rep o rate + 4%) for the delayed period, shall be submitted by the bidder. Further, if performance security is not submitted till such time the first bill becomes due, the amount of performance security due shall be r ecovered as per terms defined in NIT/contract, from the bills along with due interest.

- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
