1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. 2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are

validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

- 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 4. Short Duration Bid has been published by the Buyer with the approval of the Competent authority due to Emergency procurement of critical products/services.
- 5. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

2. SCOPE OF WORK

SUPPLY OF ORDINARY PORTLAND CEMENT (GR-43) AS PER IS 269:2015 AT NTPC LARA STAGE II (2x 800 MW), RAIGARH, CHHATTISGARH - **THROUGH BULKERS**

SITE DETAIL

Lara STPP Stage-I (2X800 MW) units are in operation near Lara village in Raigarh Distt. of Chhattisgarh. The Present tender is for the scope to be executed in Lara STPP, Stage-II (2x800 MW) as extension of existing stage-I.

The project is located in Raigarh district of Chhattisgarh State. The project is located south-east of Raig arh town near village Lara, bounded by villages Lara, Chhapora & Lohakhan and on the western side of Odisha State boundary.

The project site is approachable from NH-200 (Raigarh–Sarangarh) via Kondatarai through State PWD Road. The nearest rail head Raigarh Railway Station (on South East Central Railway, Howrah-Bilaspur Broad Gauge), is approximately 30 kms from the project site. The nearest commercial airport, Raipur is about 250 kms from the project site.

3. TAXES AND DUTIES

3.1 Bidder's quoted/ accepted rates/ price shall be inclusive of all taxes including GST, Charges, Royalties, any State or Central Levy and other taxes for materials if any obtained for the work and for execution of the contract.

Any increase of above at any stage during execution of contract, including extension of the contract, shall have to be borne by successful bidder contractor. However, any increase of GST subsequent to due date of offer submission as per NIT & TCN, by statutory authority during contract period (including extension, if the same is not attributable to you), shall be reimbursed by BHEL on production of relevant supporting do cument to the satisfaction of BHEL.

Benefit of any decrease of taxes including GST, Charges, Royalties, any State or Central Lev y and other taxes for materials if any obtained for the work and for execution of the contract; subsequent to due date of offer submission as per NIT & TCN, by statutory authority shall be passed on to BHEL.

3.2 Successful bidder shall furnish proof of GST registration with GSTN Portal covering the services under this contract.

Registration should also bear endorsement for the premises from where the billing shall be done by succe ssful bidder on BHEL for this project / work.

- 3.3 Since GST on output will be paid by BHEL as enumerated above, bidder's quoted rates / price should b e after considering the Input Credit under GST law at bidder's end.
- 3.4 TDS under Income Tax Act shall be deducted as per prevailing IT rules from the bills.
- 3.5 TDS under GST shall be deducted as per prevailing GST rules from the bills.
- 3.6.1 You may collect TCS under section 206C(1H) of Income Tax Act, 1961 if applicable.
- 3.6.2 In case, you collect TCS under section 206C(1H) of Income Tax Act, 1961, following compliance is re quired.
- 3.6.2.1 TAN and PAN of vendor should appear in all invoices/claims. Copy of TAN /TCS registration is to be submitted.

3.8 Successful bidder to intimate immediately on the day of removal of goods (in case of any supply of go ods) to BHEL along with all relevant details and send a scanned copy of Tax Invoice to BHEL through following communication mode for enabling BHEL to meet its GST related compliances.

Portal address and Email address - Shall be intimated later.

Specific details of above shall be intimated to successful bidder by BHEL at appropriate juncture.

- 3.9 In case of delay in submission of above-mentioned documents on the date of dispatch, BHEL may incu r penalty/ interest for not adhering to Invoicing Rules under GST Law. The same will be liable to be recove red from successful bidder, in case such delay is not attributable to BHEL.
- 3.10 In case of raising any Supplementary Tax Invoice (Debit / Credit Note), successful bidder shall issue the same containing all the details as referred to in Section 34 read with Section 31 of GST Act & Rules referred there under.
- 3.11 Successful bidder shall comply with the Time Limit prescribed under the GST Law and rules thereof f or raising of the Tax Invoice. If any supply of goods is applicable, successful bidder shall also ensure prompt delivery of goods after dispatch.
- 3.12 Bidder shall note that in case GST credit is delayed / denied to BHEL due to delayed / non-receipt of goods and / or Tax Invoice or expiry of the timeline prescribed in GST Law for availing such ITC, or any oth er reasons, not attributable to BHEL, GST amount shall be recoverable from successful bidder along with i nterest levied/ leviable on BHEL, as the case may be.
- 3.13 Successful bidder shall upload the invoices raised on BHEL in IFF/GSTR-1 within the prescribed time as given in the GST Act, and the same should be available to BHEL in FORM GSTR-2B electronically through the common portal; and confirmation of payment of such GST to the Government through filing of GSTR-3B of corresponding month/quarter.

Bidder shall note that in case of delay in declaring such invoice in your return and GST credit availed by B HEL is denied or reversed subsequently as per GST Law, GST amount paid by BHEL towards such ITC reve rsal as per GST law shall be recoverable from the successful bidder along with interest levied / leviable on BHEL.

- 3.14 Successful bidder to arrange for e-waybill for any movement of goods for the execution of the contra ct. 5. REJECTION

In case any material is found defective or unsuitable at our works/Site after supply, the same shall be subjected to test by third party and the result of the third-party test shall be acceptable and binding to the vendor. In case the test results show that the material does not conform to the standards specified, the whole I ot shall be rejected, taken back by the vendor and replaced by the acceptable material at vendor's cost.

6. SPECIAL INSTRUCTIONS

- 6.5. Quality of cement is associated with shelf life. Shelf life of cement supplied should be in line with IS specification, considering manufacturing & transit time so that minimum 8 weeks self-life is available from the date of receipt at site, for use of BHEL.
- 6.6. Copy of Manufacturer's test result in original for 7 & 28 days submitted by successful bidder is to be accepted by BHEL/Site.
- 6.7. Site Receipt Voucher shall be generated at site
- 6.8. The material should be delivered in original manufacturer's temper proof sealed packing. Packing shall be in Bulker only.
- 6.9. Transit Insurance shall be in scope of BHEL
