- 1. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer. 2. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The

3. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the

Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

- 4. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
  - i. If number of technically qualified bidders are only 2 or 3.
  - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
  - iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
  - iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
  - v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

Description: Supply, erection and commissioning of Skid mounted Balance of plant (BO P) for 5 kW Alkaline Electrolyser system without stack

- 1) Pre-Qualification Criteria:
- **1a) Supply experience:** Bidder should have supplied minimum One number of Test Stations or C omplete Systems or Balance of Plant of rating >=200 Watts for Electrolyser or Fuel Cell application in the last 5 years from date of the enquiry. As a documentary proof for the supplied system, bid der should submit copy of Purchase Order / Installation Report/ Completion certificate.

The supplied system should have minimum 30 days working /operating hours. As a proof for the w orking hours, bidder should submit working / operating hours evidence from the customer.

- **1b) OEM Authorization:** Bidder should be an OEM / OEM authorized vendor of Test Station or Co mplete System or Balance of Plant for Electrolyser or Fuel Cell application. Valid Authorization Cert ificate to be provided.
- **1c) Relaxation of Norms for Start-ups:** The condition of Prior Turnover and prior experience is relaxed for all start-ups whether Micro & Small Enterprises (MSEs) or otherwise subject to meeting of quality and technical specifications in accordance with the relevant provision of GFR,2005 and other DOE-PPD notifications for relaxation norms for start-ups issued from time to time.
- **2) Payment term:** 90% payment of Supply value will be made within the stipulated days as men tioned below from the date of receipt and acceptance of material at BHEL R&D, Hyderabad.

Type of bidder:

- A. For Micro & Small enterprises (MSEs) payment will be made within 45 days
- B. For Medium Enterprises will be made within 60 days
- C. Non MSMEs will be made within 90 days

Balance 10% of supply value plus 100% of the E&C portion of PO Value will be paid against E&C c ertificate issued by BHEL and submission of Performance Bank Guarantee (PBG) by supplier.

However, GST Portion of Invoice shall be released only upon:

- i) Vendor declaring the Invoice in their GSTR-1.
- ii) Receipt of Goods and Tax Invoice by BHEL.
- iii) Confirmation of Payment of GST thereon by vendor on GSTN.
- **3) Performance Bank Guarantee (PBG):** PBG from any one of the Consortium Banks of BHEL f or 10% of total order value is to be submitted by the successful vendor and shall be kept valid up to guarantee/warranty period with additional claim period of 3-6 months thereafter. The offers of t he suppliers not accepting to this clause will be rejected.

Note: Pro-forma of Performance Bank Guarantee is attached in ATC document.

- **4) Interest for delayed submission of performance security (PBG):** PBG of 10% of total ord er value is to be submitted by the successful vendor within 14 days from the date of successful completion of erection & commissioning at BHEL Corporate R&D. Bidder agrees to submit performance security required for execution of the contract within the time period mentioned. In case of delay in submission of performance security, enhanced performance security which would include interest (Reporate + 4%) for the delayed period, shall be submitted by the bidder. Further, if performance security is not submitted till such time the bill becomes due, the amount of performance security due shall be recovered as per terms defined in NIT/contract, from the bills along with due interest.
- **5) Technical Specification:** Bidder shall submit compliance on attached BHEL Technical specific ation (Annexure-A) uploaded in Buyer Specification Document.
- **6) Compliance on restrictions under Rule 144 (XI) of the GFR:** Submit the Annexure B whi ch is attached in ATC document.
- **7) Delivery period:** Total delivery period is 25 weeks from PO date for complete scope i.e. submi ssion of drawings and documents, approval of drawings and documents, delivery of all the items, E&C intimation and Completion of E&C including training. Delivery period break up for each activit y is indicated in BHEL Technical specification (Annexure-A) uploaded in Buyer Specification Document.
- **8) Terms of Delivery**: Free on Road (FOR) BHEL R&D, Hyderabad.
- **9) Safety and statutory requirement:** The contractor / vendor shall ensure all safety and statutory requirement related to its staff.
- **10)** Vendor has to quote prices inclusive of GST and other applicable charges.
- **11)** Vendor has to submit this GeM bid document duly signed and stamped on all pages. By submitting singed Gem bid document it affirms that vendor has accepted to all terms and conditions mentioned in this bid such as payment terms, performance bank guarantee, Interest for delayed submission of performance security (PBG), delivery period, Terms of Delivery etc.

## 12) Breach of contract, Remedies and Termination:

In case of breach of contract, wherever the value of security instruments like performance bank g uarantee available with BHEL against the said contract is atleast 10% of the contract value, the sa me be encashed. In case the value of the security instruments available is less than 10% of the contract value, the balance amount be recovered from other financial remedies (i.e. available bills of the contractor, retention amount, etc. with BHEL) or legal remedies be pursued. Further, levy of liq

uidated damages, debarment, termination, de-scoping, short-closure, etc., shall be applied as per provisions of the contract.

- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
