1. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM_No.1_4_2021_PPD_dated_18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

Buyer Added Bid Specific Terms and Conditions/क्रेता द्वारा जोड़ी गई बिड की विशेष शर्तें

1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1a) Pre-Qualification Criteria : Vendor/bidder shall submit at least one Purchase order (PO) copy which they have obtained for supply of 55inch and above Interactive flat panel/int eractive panel in the last 5 years from date of enquiry.

1b) Relaxation of Norms for Startups: The condition of Prior Turnover and prior experience is relaxed for all startups whether Micro & Small Enterprises(MSEs) or otherwise subject to meeting of quality and technical specifications in accordance with the relevant provision of GFR,2005 and other DOE-PPD notifications for relaxation norms for startups issued from time to time.

2) Payment term: 100% payment shall be made within the stipulated days as mentioned below from the date of completion of entire scope of work (Supply, Installation and commissioning) of Items/material/equipment at BHEL Corporate R&D Vikasnagar, Hyderabad and submission of PBG by vendor in prescribed format.

Type of bidder :

A.For Micro & Small enterprises(MSEs) payment will be made within 45 days

B. For Medium Enterprises will be made within 60 days

C. Non MSMEs will be made within 90 days

However, GST Portion of Invoice shall be released only upon:

i) vendor declaring the Invoice in their GSTR-1.

ii) Receipt of Goods and Tax Invoice by BHEL.

iii) Confirmation of Payment of GST thereon by vendor on GSTN.

3) Restriction under rule 144 : Submit signed and stamped document (on letter head) of Annexure - 144 which is attached in Buyer uploaded ATC document (Page 1 of 6).

4) **Performance Bank Guarantee (PBG) :** PBG of 10% of total order value is to be submitted by the successful vendor and shall be kept valid up to guarantee period. Expiry of claim period may be kept 3-6 months after validity date. PBG shall be from one of the Consortium banks of BHEL or from a reputed bank and confirmed by any Consortium bank of BHEL. The offers of the suppliers not accepting to this clause will be rejected. Note : Pro-forma of PBG is attached in Page 2 to 6 of Buyer Uploaded ATC document.

5) **Interest of delayed submission of PBG :** PBG of 10% of total order value is to be submitted by the successful vendor within 15 days from the date of completion of entire scope of work (supply, installation and commissioning). Bidder agrees to submit PBG required for execution of the contract within the time period mentioned. In case of delay in submission of PBG enhanced amount which would include (Repo rate + 4%) for delayed period shall be submitted by the bidder. Further if PBG is not submitted till that time the first bill comes due, the amount of PBG due shall be recovered as per terms defined in the NIT/contract from the bills along with due interest.

6) Vendor has to submit this GEM bid document duly signed and stamped on all pages. By submitting signed GEM bid document it affirms that vendor has accepted to all the terms and conditions mentioned in the bid such as payment terms, PBG, warranty clause, delivery period etc

7) Vendor has to quote price(s) inclusive of GST and other applicable charges. Note that shipping, Transportation, unloading of equipment at BHEL R&D shall be in the scope of bidder only.

8) **Breach of contract, Remedies and Termination :** In case of breach of contract, wherever the value of security instruments like performance bank guarantee available with BHEL against the said contract is at least 10% of the contract value, the same be encashed. In case the value of the security instruments available is less than 10% of the contract value, the balance amount be recovered from other financial remedies (i.e., available bills of the contractor, retention amount, etc. with BHEL) or legal remedies be pursued. Further, levy of liquidated damages, debarment, termination, de-scoping, short-closure, etc., shall be applied as per provisions of the contract.

9) **Delivery period breakup:** The delivery period 91 days (from PO) is for complete scope i.e. Supply, Installation and commissioning. Schedule for each activity is as mentioned below:

i) Supply: Material are to be delivered within 10 weeks from the date of P.O.

ii) Installation/Commissioning : Vendor to complete Installation and Testing activities within 3 (THREE) weeks from the date of receipt of material at BHEL R & D.

BHEL site is ready, hence installation work can be started from date of receipt of material at BHEL R & D.

10) Penalty for Delay in supply and commissioning:

10a) For the purpose of penalty for delay in installation/ commissioning of the equipment (75 inch interactive flat panel with OPS) the duration will be reckoned from the date of receipt of material at BHEL R & D as site is ready for installation work.

10b) Penalty on delay in 'Supply' and/or 'commissioning' will be applicable to the delays attributed to vendor.

Penalty will be considered separately for 'Supply' and 'commissioning'.

The rate of penalty for delayed Supply shall be @ 0.5% per week of delay of total PO value (Supply+ Commissioning) in supply subject to a maximum of 10% of total PO value (Supply + commissioning).

The rate penalty for delayed commissioning shall be @0.5% per week of delay of total PO value (Supply +commissioning) in commissioning subject to a maximum of 10% of total PO value (Supply + commissioning).

Maximum penalty for delay in Supply and commissioning together shall be limited to 15% of total PO value (Supply+ commissioning).

10C) Incase, any shortage is noticed viz-a-viz PO requirement in the equipment (75inch Interactive flat panel with OPS), such shortages shall be replenished by supplier on for destination basis without any cost implication to BHEL i.e. Custom Duty and freight charges etc. up to destination for such short supplies shall be borne by the supplier.

2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
