5. Price bid shall be opened for only customer approved vendor .
6. Credentials as per **Annexure- sub vendor questionnaire** format is to be submitted by bidders along with the offer for customer approval. Offers will not be considered if customer does not approve any bidder. Further, Bidder shall confirm any additional customer specific bidder approval requirements as per customer approval letter (if any) without any financial implication else their offer shall not be considered.
