In case no security instruments are available or the value of the security instruments available is less than 10% of the contract value, the 10% of the contract value or the balance amount, as the case may be, will be recovered in all or any of the following mann ers:

- a. from dues available in the form of Bills payable to defaulted supplier against the same contract.
