15. Inspection

i) A bidder's EMD will be forfeited if the bidder withdraws or amends its/his tender or impairs or

derogates from the tender in any respect within the period of validity of the tender or if the

successful bidder fails to furnish the required performance security within the specified period

mentioned in the Tender.

(ii) EMD by the tenderer to be withheld in case any action on the bidder is envisaged under the provisions of extant "Guidelines on Suspension of business dealings with suppliers/ contractors" and forfeited/ released based on the action as determined under these guidelines.

17. Performance Security:

To ensure due performance of the contract, Performance Bank Guarantee (PBG) or Security Deposit (SD), hereafter referred as performance security is to be obtained from the successful bidder awarded the contract.

Total amount of performance security shall be 5 % of total PO value.

Performance security is to be furnished by 14 days after date of PO and it should remain valid for a period of 60 days beyond the date of completion of all contractual obligations of the supplier, including warranty obligations.

(v) Insurance Surety Bond.

(Note: BHEL will not be liable or responsible in any manner for the collection of interest or renewal of the documents or in any other matter connected therewith)

- 18.** Payment terms shall be as per followings. Offers of vendors are liable for rejection in case of non-acceptance of payments terms as mentioned below:

For Non MSEs bidder:

- a) 80 % payment along with taxes, freight & insurance will be made after receipt and acceptance of material and within 90 days subject to submission of non-discrepant documents within 15 days of supply as per terms and conditions of Purchase Order.
- b) Final acceptance of material (After SRV Clearance) will be given after completion of preliminary machining at BHEL Haridwar (within 270 days after receipt of material).
- c) Balance 20% Payment to be released after final acceptance as mentioned above (within 270 days from Invoice date).

For MSEs bidder:

- a) For MSEs (covered under MSME Act) which are registered and periodically renewed with BHEL, 80% payment will be made within 45 days or as prescribed in the relevant act. 20. Breach of contract, Remedies and Termination:

In case of breach of contract, wherever the value of security instruments like performance bank guarantee available with BHEL against the said contract is 10% of the contract

t value or more, such security instruments to the extent of 10% contract value will be encashed. In case the value of the security instruments available is less than 10% of the contract value, the balance amount will be recovered in all or any of the following manners:

i. from dues available in the form of Bills payable to defaulted supplier against the same contract.

ii. from the dues payable to defaulted supplier against other contracts in the same Region/Unit /any

other region/unit

iii. In-case recoveries are not possible with any of the above available options, Legal action shall be

initiated for recovery against defaulted supplier.

Further, levy of liquidated damages, debarment, termination, de-scoping, short-closure, etc., will be

applied as per provisions of the contract

21. Conflict of Interest: "A bidder shall not have conflict of interest with other bidders. Such conflict of interest can lead to anti-competitive practices to the detriment of Procuring Entity's interests. The bidder found to have a conflict of interest shall be disqualified. A bidder may be considered to have a conflict of interest with one or more parties in this bidding process, if:

a) they have controlling partner (s) in common; or

b) they receive or have received any direct or indirect subsidy/ financial stake from any of them; or

c) they have the same legal representative/agent for purposes of this bid; or

d) they have relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the bid of another Bidder; or

e) Bidder participates in more than one bid in this bidding process. Participation by a Bidder in more than one Bid will result in the disqualification of all bids in which the parties are involved. However, this does not limit the inclusion of the components/ sub-assembly/ Assemblies from one bidding manufacturer in more than one bid; or

f) In cases of agents quoting in offshore procurements, on behalf of their principal manufacturers, one agent cannot represent two manufacturers or quote on their behalf in a particular tender enquiry. One manufacturer can also authorize only one agent/dealer. There can be only one bid from the following:
