Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. 20. Payment terms shall be as per followings. Offers of vendors are liable for rejection in case of non-acceptance of payments terms as mentioned below:

For Non MSEs bidder:

- 80 % payment along with taxes, freight & insurance will be made after receipt and acceptance of material and within 90 days subject to submission of non-discrepant documents within 15 days of supply as per terms and conditions of Purchase Order.
- Final acceptance of material (After SRV Clearance) will be given after completion of preliminary machining at BHEL Haridwar (within 270 days after receipt of material).
- Balance 20% Payment to be released after final acceptance as mentioned above (within 270 days from Invoice date).

For MSEs bidder:
