- 1. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted
- 2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 3. Short Duration Bid has been published by the Buyer with the approval of the Competent authority due to Emergency procurement of critical products/services.

ECO-Mark - Eco Mark is applicable as per G.S.R. 85(E) dated 21st February 1991 (Annexure - I) for this category. As such Buyers may also opt for eco mark labelled product while creating Bid. In such cases buyer shall verify Eco mark label at the time of evaluation of BID/receipt of material before issuing CRAC.

- **1a) Pre-Qualification Criteria :** Vendor shall submit at least one Purchase Order copy of supplying A4 X erox copier papers (white color) to any organization during last five years from date of enquiry
- **1b) Relaxation of Norms for Startups:** The condition of Prior Turnover and prior experience is relaxed f or all startups whether Micro & Small Enterprises(MSEs) or otherwise subject to meeting of quality and tec hnical specifications in accordance with the relevant provision of GFR,2005 and other DOE-PPD notification s for relaxation norms for startups issued from time to time.
- **2) Payment term:** 100% basic payment shall be made within the stipulated days as mentioned below from the date of receipt and acceptance of material at BHEL Corporate R&D Vikasnagar, Hyderabad.

Type of bidder:

- **4) PDI (Pre Dispatch Inspection) :** Inspection of A4 80 GSM paper shall be carried out by Corp. BHEL R &D at vendor works place or through virtual mode or vendor has to submit sample ream after placement o f order. Inspection work(s) to be completed with in 15 days from PO release date.
- 5) Vendor has to submit this GEM bid document duly signed and stamped on all pages. By submitting sing ed GEM bid document it affirms that vendor has accepted to all the terms and conditions mentioned in the bid such as payment terms, delivery period etc.
- 6) Vendor has to quote price(s) inclusive of GST , transportation charges, loading/unloading of the material(s) charges, if any. Please make note that unloading of material at BHEL R&D stores is in scope of vendor only. Vendor has to arrange sufficient manpower accordingly.
- 7) Breach of contract, Remedies and Termination: In case of breach of contract, wherever the value of security instruments like performance bank guarantee available with BHEL against the said contract is a tleast 10% of the contract value, the same be encashed. In case the value of the security instruments avail able is less than 10% of the contract value, the balance amount be recovered from other financial remedie s (i.e., available bills of the contractor, retention amount, etc. with BHEL) or legal remedies be pursued. Further, levy of liquidated damages, debarment, termination, de-scoping, short-closure, etc., shall be applied as per provisions of the contract.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
