- 1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.
- 2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 3. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
 - i. If number of technically qualified bidders are only 2 or 3.
 - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
 - iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
 - iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
 - v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

2. Generic

- 1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- 2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

3. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

4. Generic

While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

5. Scope of Supply

6. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

7. Buyer Added Bid Specific ATC

- **A. Type of Tender** This is an open e-tender & only online offers in GEM portal s hall be considered. Compliance of attached PQR & special instructions are the sole criteria of offer qualification.
- **B. Late Deliveries** If the Seller fails to deliver any or all of the Goods/Services w ithin the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covere d under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delay ed quantity per week or part of the

week of delayed period as pre-estimated damages not exceeding 10% of the cont ract value of delayed quantity without any controversy/ dispute of any sort whatso ever.

- **C. Special Instruction** C.1 After award of contract, Successful Bidder shall hav e to get sample approved from buyer in advance before bulk manufacturing / start ing bulk supplies.
- C.2 Successful Bidder other than BHEL approved vendor, shall submit 02 numbers of TUNGSTEN ELECTRODES free of cost as per SPEC: HW7715199 REV: 01 SIZE: 2. 4X150 along with material TC for approval within 30 days of placement of PO.
- C.3 Buyer shall, as per contract specifications framework, either approve the advance sample or will provide complete list of modification required as per SPEC: HW 7715199 REV: 01 in the sample within 30 days of receipt of sample.
- C.4 The Material Acceptability, rejection or modification shall be decided alone by the buyer. Seller shall be required to ensure supply as per approved sample with modifications, if any, as communicated by Buyer.
- C.5 In case, the sample is found to have major deviations/ not conforming to the C ontract specifications, the buyer at its discretion may call for fresh samples for ap proval before allowing bulk supplies or may terminate the contract after notifying the deviations to the seller.
- C.6 Failure in establishing of samples as per Buyers requirement or non-supply of samples or any further requirement of fresh/modified samples shall be treated as failure in execution of contract.
- C.7 Unless otherwise provided in the contract, all samples required for test shall be supplied by the contractor free of cost. Where under the contract, the supplier is required to supply sample in advance, any expenses incurred by the supplier on or in connection with the production of stores in bulk, before the sample has been a pproved, unconditionally shall be borne by the Seller and they shall not claim any compensation in the event of such sample being found unacceptable by the Buyer

- **F. Conflict of interest**: A bidder shall not have conflict of interest with other bid ders. Such conflict of interest can lead to anti-competitive practices to the detrim ent of Procuring Entity's interests. The bidder found to have a conflict of interest s hall be disqualified. A bidder may be considered to have a conflict of interest with one or more parties in this bidding process, if:
- a) they have controlling partner (s) in common; or
- b) they receive or have received any direct or indirect subsidy/financial stake from any of them; or
- c) they have the same legal representative/agent for purposes of this bid; or
- d) they have relationship with each other, directly or through common third partie s, that puts them in a position to have access to information about or influence on the bid of another Bidder; or
- e) Bidder participates in more than one bid in this bidding process. Participation by a Bidder in more than one Bid will result in the disqualification of all bids in which the parties are involved. However, this does not limit the inclusion of the components/sub-assembly/Assemblies from. one bidding manufacturer in more than one bid; or
- f) In cases of agents quoting in offshore procurements, on behalf of their principal manufacturers, one agent cannot represent two manufacturers or quote on their b ehalf in a particular tender enquiry. One manufacturer can also authorize only one agent/dealer. There can be only one bid from the following: 1. The principal manufacturer directly or through one Indian agent on his behalf; and 2. Indian/foreign a gent on behalf of only one principal· or
- g) A Bidder or any of its affiliates participated as a consultant in the preparation of the design or technical specifications of the contract that is the subject of the Bidor
- h) In case of a holding company having more than one independently manufacturi ng units, or more than one unit having common business ownership/management , only one unit should quote. Similar restrictions would apply to closely related sist er companies. Bidders must proactively declare such sister/ common business/ m anagement units in same/ similar line of business.
- **G. Breach of contract**: Remedies and Termination: In case of breach of contract , wherever the value of security instruments like performance bank guarantee available with BHEL against the said contract is at-least 10% of the contract value, the same be en-cashed.

In case the value of the security instruments available is less than 10% of the cont ract value, the balance amount be recovered from other financial remedies (i.e. a vailable bills of the contractor, retention amount, etc. with BHEL) or legal remedie s be pursued. The balance scope shall be got done independently without Risk & Cost of the failed supplier/ contractor.

Further, levy of liquidated damages, debarment, termination, de-scoping, short-cl osure, etc., shall be applied as per provisions of the contract.

Rest all the terms & conditions shall be as per attached ATC & GEM GTC, unless ot herwise specified.
