1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 4. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

SUPPLY OF PORTLAND POZZOLANA CEMENT (PPC) AS PER IS:1489-PART-1:2015 (QTY- 2100 MT) AT BHEL PSER 3X660 MW NTPC NORTH KARANPURA PROJECT(EPC), TANDWA, JHARKHAND.

SITE DETAILS:

3X660 MW North Karanpura Super Thermal Power Project, a pit head coal based thermal power project, is located in Hazaribagh and Chatra districts of Jharkhand State.

Owner: NTPC (National Thermal Power Corporation).

The power project is located near Tandwa town in Chatra districts in the state of Jharkhand on Haz aribagh-Chatra State highway at a distance of about 50 kms from Hazaribagh city. The nearest commercial airport is Ranchi at a distance of about 150 kms from project site. 5. **REJECTION:**

In case any material is found defective or unsuitable at our works/Site after supply, the same shall be subjected to test by third party and the result of the third-party test shall be acceptable and bin ding to the vendor. 9. TEST CERTIFICATE:

Manufacturer's Test certificates for 7 days & 28 days are to be submitted to BHEL for acceptance. Prelimin arily Cement will be accepted on the basis of 7-days test report (MTC to be submitted by supplier for revie w by BHEL for preliminary acceptance), but final acceptance criteria will be 28 days' Manufacturer's test c ertificate.

Reference sample for each supplied lot may be collected at BHEL Site and same may be tested at BHEL la b/BHEL approved lab at the discretion of BHEL, if required. Supplier shall be available to carry out / witness Joint Sampling of Cement, if required.

In case, test results of the collected cement sample fail, the entire lot may be rejected and the supplier will have to do free replacement at their cost.

10. MATERIAL DISPATCH CLEARANCE CERTIFICATE (MDCC):
