- **1a) Pre-Qualification Criteria :** Bidder should submit at least one PO copy of 12V 42Ah (or higher rating) SMF-VRLA batteries in the last 5 (FIVE) years from the date of enquiry.
- **1b) Relaxation of Norms for Startups:** The condition of Prior Turnover and prior experience is relaxed for all startups whether Micro & Small Enterprises(MSEs) or otherwise subject to meeting of quality and technical specifications in accordance with the relevant provision of GFR,2005 and other DOE-PPD notifications for relaxation norms for startups issued from time to time.
- **2) Payment terms:** 100% basic payment shall be made within the stipulated days as mentioned below from the date of completion of entire scope of work (Supply & Installation of batteries) and acceptance at BHEL Corporate R&D Vikasnagar, Hyderabad.

Type of bidder:

A.For Micro & Small enterprises(MSEs) payment will be made with in 45 days

- B. For Medium Enterprises will be made with in 60 days
- C. Non MSMEs will be made with in 90 days

However, GST Portion of Invoice shall be released only upon:

- **8)** Breach of contract, Remedies and Termination: In case of breach of contract, wherever the value of security instruments like performance bank guarantee available with BHEL against the said contract is atleast 10% of the contract value, the same be encashed. In case the value of the security instruments availa ble is less than 10% of the contract value, the balance amount be recovered from other financial remedies (i. e., available bills of the contractor, retention amount, etc. with BHEL) or legal remedies be pursued. Further, I evy of liquidated damages, debarment, termination, de-scoping, short-closure, etc., shall be applied as per provisions of the contract.
