1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. - 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 4. Short Duration Bid has been published by the Buyer with the approval of the Competent authority due to Emergency procurement of critical products/services.
- 5. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

## 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

## 2. SCOPE OF WORK

SUPPLY OF PORTLAND POZZOLANA CEMENT (PPC) AS PER IS:1489 (PART 1):2015 AT SIPAT SUPER THERMAL POWER PROJECT, STAGE-III (1x800 MW).

#### 3. SITE DETAIL

Sipat STPP has an installed capacity of 2980 MW under commercial operation with Stage-I (3x660 MW) and Stage-II (2x500 MW). The present proposal is for Sipat STPP Stage-III (1x800 MW) with Ultra-super critical t echnology.

Sipat STPP is located in Bilaspur district of Chhattisgarh, having latitude and longitude of 220 - 05' to 220 - 09' (N) and 820 -16' to 820 - 18' (E) respectively. The site is approximately 20 Km from Bilaspur city and is approachable via Bilaspur – Baloda State Highway which passes through Sipat..

The nearest rail head is Jairamnagar Railway Station (on Nagpur-Raipur-Kolkata main line), is approximatel y 3 km from the project site. The nearest commercial airport, Raipur is about 150 Km from the project site.

#### 4. TAXES AND DUTIES

4.1 Bidder's quoted/ accepted rates/ price shall be inclusive of all taxes including GST, Charges, Royalties, any State or Central Levy and other taxes for materials if any obtained for the work and for execution of the contract.

Any increase of above at any stage during execution of contract, including extension of the contract, shall have to be borne by successful bidder contractor. However, any increase of GST subsequent to due date of offer submission as per NIT & TCN, by statutory authority during contract period (including extension, if the same is not attributable to you), shall be reimbursed by BHEL on production of relevant supporting do cument to the satisfaction of BHEL.

Benefit of any decrease of taxes including GST, Charges, Royalties, any State or Central Levy and other ta xes for materials if any obtained for the work and for execution of the contract; subsequent to due date of offer submission as per NIT & TCN, by statutory authority shall be passed on to BHEL.

4.2 Successful bidder shall furnish proof of GST registration with GSTN Portal covering the services under this contract.

Registration should also bear endorsement for the premises from where the billing shall be done by succe ssful bidder on BHEL for this project / work.

- 4.3 Since GST on output will be paid by BHEL as enumerated above, bidder's quoted rates / price should be after considering the Input Credit under GST law at bidder's end.
- 4.4 TDS under Income Tax Act shall be deducted as per prevailing IT rules from the bills.
- 4.5 TDS under GST shall be deducted as per prevailing GST rules from the bills.
- 4.6.1 You may collect TCS under section 206C(1H) of Income Tax Act, 1961 if applicable.
- 4.6.2 In case, you collect TCS under section 206C(1H) of Income Tax Act, 1961, following compliance is re quired.
- 4.6.2.1 TAN and PAN of vendor should appear in all invoices/claims. Copy of TAN /TCS registration is to be submitted.

4.8 Successful bidder to intimate immediately on the day of removal of goods (in case of any supply of go ods) to BHEL along with all relevant details and send a scanned copy of Tax Invoice to BHEL through following communication mode for enabling BHEL to meet its GST related compliances.

Portal address and Email address - Shall be intimated later.

Specific details of above shall be intimated to successful bidder by BHEL at appropriate juncture.

- 4.9 In case of delay in submission of above-mentioned documents on the date of dispatch, BHEL may incu r penalty/ interest for not adhering to Invoicing Rules under GST Law. The same will be liable to be recove red from successful bidder, in case such delay is not attributable to BHEL.
- 4.10 In case of raising any Supplementary Tax Invoice (Debit / Credit Note), successful bidder shall issue the same containing all the details as referred to in Section 34 read with Section 31 of GST Act & Rules referred there under.
- 4.11 Successful bidder shall comply with the Time Limit prescribed under the GST Law and rules thereof f or raising of the Tax Invoice. If any supply of goods is applicable, successful bidder shall also ensure prompt delivery of goods after dispatch.
- 4.12 Bidder shall note that in case GST credit is delayed / denied to BHEL due to delayed / non-receipt of goods and / or Tax Invoice or expiry of the timeline prescribed in GST Law for availing such ITC, or any oth er reasons, not attributable to BHEL, GST amount shall be recoverable from successful bidder along with i nterest levied/ leviable on BHEL, as the case may be.
- 4.13 Successful bidder shall upload the invoices raised on BHEL in IFF/GSTR-1 within the prescribed time as given in the GST Act, and the same should be available to BHEL in FORM GSTR-2B electronically through the common portal; and confirmation of payment of such GST to the Government through filing of GSTR-3B of corresponding month/quarter.

Bidder shall note that in case of delay in declaring such invoice in your return and GST credit availed by B HEL is denied or reversed subsequently as per GST Law, GST amount paid by BHEL towards such ITC reve rsal as per GST law shall be recoverable from the successful bidder along with interest levied / leviable on BHEL.

- 4.14 Successful bidder to arrange for e-waybill for any movement of goods for the execution of the contra ct. Successful bidder has to make their own arrangement at their cost for completing the formalities, if re quired, with Issuing Authorities, for bringing materials, plants & machinery at site for execution of the wor ks under this contract, Road Permit / Way Bill, if required, shall be arranged by successful bidder and BHE L will not supply any Road Permit/ Way Bill for this purpose.
- 4.15 Any new taxes & duties, if imposed subsequent to due date of offer submission as per NIT & TCN, by statutory authority during contract period (including extension, if the same is not attributable to you), shall be reimbursed by BHEL on production of relevant supporting document to the satisfaction of BHEL. ## 5. INSPECTION

BHEL reserves the right to inspect the material during manufacturing and also to get tested the material under dispatch from third party. The test results of third-party test shall be final and binding on the vend or.

BHEL will reserve the right to inspect/test the material during/after manufacturing at supplier's works, a nd/or at BHEL Site. In case of rejection at any stage, supplier shall be liable to replace at his own cost.

## 6. REJECTION

In case any material is found defective or unsuitable at our works/Site after supply, the same shall be subjected to test by third party and the result of the third-party test shall be acceptable and binding to the vendor. In case the test results show that the material does not conform to the standards specified, the whole lot shall be rejected, taken back by the vendor and replaced by the acceptable material at vendor's cost.

## 7. SPECIAL INSTRUCTIONS

7.1. The unloading of cement will be done by BHEL at site within a reasonable time.

- 7.2 Site test of cement shall be conducted as per BHEL/Customer's field quality plan. BHEL reserves the right to conduct necessary test at vendor's works if required.
- 7.3 The representative of the vendor should be available at SIPAT site whenever required as per BHEL site requirement to provide single window expeditious service a nd quality checks as per IS code.
- 7.4 Guarantee / Warranty certificate to be furnished by the successful bidder.
- 7.5 Quality of cement is associated with shelf life. Shelf life of cement supplied shoul d be in line with IS specification, considering manufacturing & transit time so that minimum 8 weeks shelf life is available from the date of receipt at site, for use of BHEL.
- 7.6. Copy of Manufacturer's test result in original for 7 & 28 days submitted by succe ssful bidder is to be accepted by BHEL/Site.
- 7.7 Site Receipt Voucher shall be generated at site.
- 7.8 Item should be delivered generally through cement bulkers. However around 5-1 0% of the order quantity may be required to be delivered in original manufacturer 's temper proof sealed packing. Packing shall be in non-returnable 50 kg bags only. The supplied cement bag must be mentioned have week number of the production and the Cement Invoice must certify the same.
- 7.9 Methodology & weighment tolerance shall be as per Anne-B of IS 1489-2015 (for cement supplied through cement bulkers).
- 7.10 Weighment of cement bulkers shall be done at BHEL/BHEL agencies' weighbri dge.
- 7.11 Weighment of supply of cement in bags (total consignment of bags shall be do ne at BHEL/BHEL agencies weighbridge.
- 7.12 For the purpose of payment, the weighment slips of weighbridge and toleranc e as per IS 1489 shall be considered.
- 7.13 Transit Insurance shall be in scope of BHEL.

## 8. **DELIVERY PERIOD**

Delivery Period shall be 120 days from placement of PO as per delivery schedule given in GEM Bid doc

ument. MDCC for dispatch of required quantity of cement shall be provided by BHEL SIPAT Site. Complete delivery of the MDCC quantity should be made at site within 25 days from the date of dispatch clearance (MDCC).

- a. Preliminary Cement will be accepted on the basis of 7-day test report (MTC to be submitted by su pplier for review by BHEL for preliminary acceptance), but final acceptance criteria will be 28 day s' test report at BHEL lab/ BHEL approved lab if required.
- b. Reference sample for each supplied lot to be collected at BHEL and same will be tested at BHEL la b/BHEL approved lab, if required supplier shall be available to carry out Joint Sampling of Cement , if required.
- d. In case, test results of the collected cement sample fails, the entire lot may be rejected and the su pplier will have to do free replacement at their cost.

## 11. MATERIAL DISPATCH CLEARANCE CERTIFICATE (MDCC)
