- 1. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 2. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria

also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover shall upload the supporting documents to prove his eligibility for exemption.

- 3. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.
- OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.
- 4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 5. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
  - i. If number of technically qualified bidders are only 2 or 3.
  - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
  - iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
  - iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
  - v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

**Description: Regenerative DC Electronic Load and Source System** 

- 1) Pre-Qualification Criteria:
- **1a) Vendor/Bidder:** The Bidder shall be the Original Equipment Manufacturer (OEM) or Authorize d dealer/ distributor/ channel partner of OEM. If the bidder is an Authorized dealer/ distributor/ channel partner of OEM, they shall submit valid authorization letter from OEM. If bidder is an OEM, he shall submit a self declaration certificate as a manufacturer.
- **1b) Experience:** The Bidder shall submit atleast one purchase order copy for minimum one no. of 10kW or higher rating Load Bank / Bidirectional Power Supply / Power Supply obtained by them or their OEM with in last 5 years from the date of this enquiry.
- **1c) Relaxation of Norms for Start-ups:** The condition of Prior Turnover and prior experience is relaxed for all start-ups whether Micro & Small Enterprises (MSEs) or otherwise subject to meeting of quality and technical specifications in accordance with the relevant provision of GFR,2005 and other DOE-PPD notifications for relaxation norms for start-ups issued from time to time.
- **2) Payment term:** 80% payment of Supply value will be made within the stipulated days as men tioned below from the date of receipt of Equipment at BHEL R&D Stores, Hyderabad.

Balance 20% of supply value plus 100% of the Installation portion of PO Value will be paid against Installation certificate issued by BHEL and Submission of Performance Bank Guarantee (PBG) by Supplier.

Type of bidder:

- A. For Micro & Small enterprises (MSEs) payment will be made within 45 days
- B. For Medium Enterprises will be made within 60 days
- C. Non MSMEs will be made within 90 days.

However, GST Portion of Invoice shall be released only upon:

- i) Vendor declaring the Invoice in their GSTR-1.
- ii) Receipt of Goods and Tax Invoice by BHEL.
- iii) Confirmation of Payment of GST thereon by vendor on GSTN.
- **3) Compliance on restrictions under Rule 144 (XI) of the GFR:** Submit the Annexure A whi ch is attached in ATC document.
- **4) Compliance on Treatment of cases regarding conflict of interest:** Submit the Annexure B which is attached in ATC document.
- **5) Compliance on Public Procurement (Preference to Make in India) order:** Submit the An nexure-C which is attached in ATC document.
- **6) Technical Specification:** Bidder shall submit compliance on attached BHEL Technical specific ation (Annexure-I) uploaded in Buyer Specification Document.
- 7) Terms of Delivery: FOR BHEL R&D, Hyderabad.
- 8) Delivery period:
- 8a) Delivery of Equipment: Should be completed within 140 days from the date of order
- **8b)** Installation & Demonstration: Should be completed within 20 days from the date of BHEL's intimation.
- **9) Earnest Money Deposit (EMD):** Submission of earnest money deposit (EMD) along with offer is required.

EMD is to be deposited in cash (as permissible under IT act), or by pay order/Demand Draft drawn in favour of BHEL R&D-A/c 10202162640, Vikasnagar, Hyderabad 500 042. EMD amount will be returned to all unsuccessful bidders after placement of order. EMD amount shall not carry any inte rest. The EMD of successful bidder will be returned after submission of CEBG.

EMD by the Tenderer will be forfeited as per NIT conditions, if:

- i) After opening the tender and within the offer validity period, the tenderer revokes his tender or makes any modification in his tender which is not acceptable to BHEL.
- ii) The Contractor fails to deposit the required Security deposit or commence the work within the p eriod as per LOI/ Contract. EMD by the tenderer shall be withheld in case any action on the tender er is envisaged under the provisions of extant "Guidelines on Suspension of business dealings with suppliers/ contractors" and forfeited/ released based on the action as determined under these guidelines.

10) Contract Execution Bank Guarantee (CEBG): The successful vendor shall have to furnish

a Contract Execution Bank Guarantee (CEBG) for 10% of the Total PO value in the prescribed form at within 30 days from the date of P.O. CEBG shall be from one of the Consortium Banks of BHEL or from a reputed Bank and confirmed by any Consortium Bank of BHEL. All bank charges on account of issuance and conformation of CEBG will have to be borne by the vendor. CEBG shall be kept valid until 30 days after the date of E&C Certificate, which will be issued on completion of Erection & Commissioning of equipment which includes erection, commissioning, job proving, performance test, training to operators etc. as prescribed in PO.

If the supplier fails to submit the CEBG even within 60 days from the date of PO, BHEL reserves the right to cancel PO & forfeit the EMD given by the supplier. In addition, in such case, action will be initiated in line with extant guidelines for Suspension of Business dealings with Suppliers.

Under all circumstances, CEBG shall be kept valid till the PBG becomes operational.

**11) Performance Bank Guarantee (PBG):** PBG of 10% of total order value is to be submitted by the successful vendor and shall be kept valid up to guarantee period. Expiry of claim period may be kept 3-6 months after validity date. PBG shall be from one of the Consortium banks of BHEL or from a reputed bank and confirmed by any Consortium bank of BHEL. The offers of the suppliers not accepting to this clause will be rejected.

**12) Interest of delayed submission of PBG and CEBG:** Bidder agrees to submit Contract Exec ution Bank Guarantee (CEBG) with-in 30 days from the date of P.O and performance bank guarant ee (PBG) with-in 15 days from the date of completion of Installation & demonstration. In case of de lay in submission of CEBG or PBG, enhanced BG which would include interest (Repo rate + 4%) for the delayed period, shall be submitted by the bidder.

Further, if performance security is not submitted till such time the first bill becomes due, the amo unt of performance security due shall be recovered as per terms defined in NIT/contract, from the bills along with due interest.

#### 13) SFMS Confirmation of Bank Guarantees (BGs) :

Vendor/Contractor/Bidder to ensure that issuance of Bank Guarantee shall be confirmed by the iss uing Bank directly to the Owner mandatorily through Structured Financial Messaging System (SFM S), as it provides an RBI supported Integrated Platform for Bank Guarantee Verification.

SBI Bank has been designated as BHEL Corporate R&D's Bank for receiving SFMS messages for BG s issued in favour of BHEL Corporate R&D.BG shall only be obtained from Banks and Branches whi ch are live on SFMS platform i.e. which have infrastructure to issue SFMS confirmation message al ong with the BG.

#### 14) Penalty for Delay in Supply and E&C (Installation & Demonstration):

- **14a)** For the purpose of penalty for delay in E&C of the equipment the duration will be reckoned fr om the date of intimation by BHEL to vendor for readiness of site.
- **14b)** Penalty on delay in 'Supply' and/or 'E&C' will be applicable to the delays attributed to vendor. Penalty will be considered separately for 'Supply' and 'E&C'. The rate of penalty for delay ed Supply shall be @ 0.5% per week of delay of total PO value (Supply + E&C) in supply subject to a maximum of 10% of total PO value (Supply + E&C). The rate penalty for delayed E&C shall be @0.5% per week of delay of total PO Value (Supply + E&C) in E&C subject to a maximum of 10% of total PO value (Supply + E&C). Maximum penalty for delay in Supply and E&C together shall be limited to 15% of total PO value (Supply + E&C).
- **14c)** In case, any shortage is noticed viz-a-viz PO requirement in the main equipment/spares, suc h shortages shall be replenished by supplier on for destination basis without any cost implication t o BHEL i.e. P&F and freight charges et c. up to destination for such short supplies shall be borne b y the supplier.
- **15)** Vendor has to submit this GeM bid document duly signed and stamped on all pages. By submitting singed Gem bid document it affirms that vendor has accepted to all terms and conditions mentioned in this bid such as payment terms, delivery period, Terms of Delivery, CEBG, PBG, Interest of delayed submission of PBG and CEBG, Breach of contract, Remedies and Termination etc.
- **16)** Vendor has to quote price(s) inclusive of GST, Transportation/Insurance, Loading/Unloading charges. Insurance, loading/unloading from vendor site to BHEL R&D, Hyderabad will be in vendor scope only.
- **17) Banned firms:** The offers of the bidders who are under suspension as also the offers of the bi dders, who engage the services of the banned firms / principal / agents, shall be rejected. The list of banned firms is available on BHEL web site www.bhel.com.

## 18) Breach of contract, Remedies and Termination:

In case of breach of contract, wherever the value of security instruments like performance bank g uarantee available with BHEL against the said contract is atleast 10% of the contract value, the sa me be encashed. In case the value of the security instruments available is less than 10% of the contract value, the balance amount be recovered from other financial remedies (i.e. available bills of the contractor, retention amount, etc. with BHEL) or legal remedies be pursued. Further, levy of liquidated damages, debarment, termination, de-scoping, short-closure, etc., shall be applied as per provisions of the contract.

#### 19) Invoice registration and documents upload in SUVIDHA portal by suppliers :

Irrespective of the value of the invoice amount, the bidder/vendor should necessarily upload the d espatch & invoice details on BHEL SUVIDHA portal at https://suvidha.bhel.in/suvidha/, prior to desp atch. All documents as per PO checklist, along with additional documents (if any), must be uploade d on the portal. It is mandatory that tax invoices with a net amount (including taxes) exceeding Rs five lakhs uploaded on the portal are digitally signed using a Class 3 Digital Signature Certificate (DSC) issued by a licensed Certifying Authority. Submission of invoice document in hard copy is all owed for invoices with a net amount (including taxes) equal to and upto Rs five lakhs, in case they were not digitally signed and uploaded on the portal. The material will not be accepted inside BHE L in absence of the above.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)

- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document.
