- 1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 4. Short Duration Bid has been published by the Buyer with the approval of the Competent authority due to Emergency procurement of critical products/services.

- 5. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity  $\div$  Original quantity)  $\times$  Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

#### 3. TAXES AND DUTIES

3.1 Bidder's guoted/ accepted rates/ price shall be inclusive of all taxes including GST, Charges, Royalties, any State or Central Levy and other taxes for materials if any obtained for the work a nd for execution of the contract.

Any increase of above at any stage during execution of contract, including extension of the con tract, shall have to be borne by successful bidder contractor. However, any increase of GST su bsequent to due date of offer submission as per NIT & TCN, by statutory authority during contra ct period (including extension, if the same is not attributable to you), shall be reimbursed by BH EL on production of relevant supporting document to the satisfaction of BHEL.

Benefit of any decrease of taxes including GST, Charges, Royalties, any State or Central Levy a nd other taxes for materials if any obtained for the work and for execution of the contract; subsequent to due date of offer submission as per NIT & TCN, by statutory authority shall be passed on to BHEL.

3.2 Successful bidder shall furnish proof of GST registration with GSTN Portal covering the servi ces under this contract.

Registration should also bear endorsement for the premises from where the billing shall be don e by successful bidder on BHEL for this project / work.

- 3.3 Since GST on output will be paid by BHEL as enumerated above, bidder's quoted rates / pric e should be after considering the Input Credit under GST law at bidder's end.
- 3.4 TDS under Income Tax Act shall be deducted as per prevailing IT rules from the bills.
- 3.5 TDS under GST shall be deducted as per prevailing GST rules from the bills.
- 3.6.1 You may collect TCS under section 206C(1H) of Income Tax Act, 1961 if applicable.
- 3.6.2 In case, you collect TCS under section 206C(1H) of Income Tax Act, 1961, following compli ance is required.
- 3.6.2.1 TAN and PAN of vendor should appear in all invoices/claims. Copy of TAN /TCS registrati on is to be submitted.

3.9 In case of delay in submission of above-mentioned documents on the date of dispatch, BHE L may incur penalty/ interest for not adhering to Invoicing Rules under GST Law. The same will b e liable to be recovered from successful bidder, in case such delay is not attributable to BHEL.

- 3.10 In case of raising any Supplementary Tax Invoice (Debit / Credit Note), successful bidder s hall issue the same containing all the details as referred to in Section 34 read with Section 31 of GST Act & Rules referred there under.
- 3.11 Successful bidder shall comply with the Time Limit prescribed under the GST Law and rules thereof for raising of the Tax Invoice. If any supply of goods is applicable, successful bidder shall also ensure prompt delivery of goods after dispatch.
- 3.12 Bidder shall note that in case GST credit is delayed / denied to BHEL due to delayed / non-receipt of goods and / or Tax Invoice or expiry of the timeline prescribed in GST Law for availing such ITC, or any other reasons, not attributable to BHEL, GST amount shall be recoverable from successful bidder along with interest levied/ leviable on BHEL, as the case may be.
- 3.13 Successful bidder shall upload the invoices raised on BHEL in IFF/GSTR-1 within the prescribed time as given in the GST Act, and the same should be available to BHEL in FORM GSTR-2B e lectronically through the common portal; and confirmation of payment of such GST to the Gove rnment through filing of GSTR-3B of corresponding month/quarter. - 4.2 During the period of mass concreting and concreting of important structures/ found ations, un-interrupted supply of cement is envisaged. BHEL site shall give advance w ritten intimation of required cement quantity (tentatively upto 1000 MT for supply wi thin 3 days) to supplier before 7 days of such mass concreting/ concreting of important foundations. MDCC in such cases shall be issued at appropriate juncture and supplier to ensure un-interrupted delivery of cement and necessary logistics for delivering the required cement quantity within 3 days from MDCC.

### 5. MATERIAL DISPATCH CLEARANCE CERTIFICATE (MDCC)

MDCC for dispatch of required quantity of cement shall be issued by BHEL KODERMA site. Sup ply shall be in line with respective MDCC. No material shall be dispatched by supplier without Material Dispatch Clearance Certificate (MDCC) issued by BHEL Site. Each consignment will be accompanied by copy of MDCC.

#### 6. SPECIAL INSTRUCTIONS

- 6.1 The unloading of cement will be done by BHEL at site within a reasonable time.
- 6.2 Site test of cement shall be conducted as per BHEL/Customer's field quality plan. BHEL reserves the right to conduct necessary test at vendor's works if required.

- 6.3 The representative of the vendor should be available at Koderma site whenever required as per BHEL site requirement to provide single window expeditious service and joint sampling, quality checks as per IS code.
- 6.4 Guarantee / Warranty certificate to be furnished by the successful bidder.
- 6.5 Quality of cement is associated with shelf life. Shelf life of cement supplied should be in line with IS sp ecification, considering manufacturing & transit time so that minimum 8 weeks shelf life is available fr om the date of receipt at site, for use of BHEL. Bidder shall ensure supply of cement at site accordingly
- 6.6 Copy of Manufacturer's test certificate in original for 7 & 28 days test result submitted by successful bi dder is to be accepted by BHEL/Customer.
- 6.7 Store Receipt Voucher shall be generated at site.
- 6.8 Item should be delivered through cement bulkers. However around 1-5% of the order quantity may be required to be delivered in original manufacturer's temper proof sealed packing in 50 kg bags.
- 6.9 In case of cement supply in bags:
  - a. The week number must be mentioned in the supplied cement bags and also in the corresponding cement invoice.
  - b. Weighment of total consignment shall be done at BHEL / BHEL agencies' weighbridge.
  - c. Methodology & weighment tolerance shall be as per Annex-B of IS 1489.
  - d. For the purpose of payment, the weighment slips of weighbridge and tolerance as per IS 1489 sh all be considered.
- 6.10 Weighment of cement bulkers shall be done at BHEL / BHEL agencies' weighbridge. For the purpos e of payment, the weighment slips of weighbridge shall be considered.
- 6.11 Transit Insurance shall be in scope of BHEL. Details of policy and underwriter shall be suitably intimat ed to the successful bidder.

he test results of third-party test shall be final and binding on the vendor. In case of rejection at any stage, supplier shall be liable to replace at his own cost.

# 9. REJECTION

In case any material is found defective or unsuitable at our works/Site after supply, the same s hall be subjected to test by third party and the result of the third-party test shall be acceptable and binding to the vendor. In case the test results show that the material does not conform to the standards specified, the whole lot shall be rejected, taken back by the vendor and replace d by acceptable material at vendor's cost.

#### 10. QUALITY INSTRUCTION

- a. Preliminary acceptance of Cement will be on the basis of 7-day test report as per MTC submit ted by supplier. Final acceptance criteria will be 28 days test report as per supplier's MTC or if required at BHEL lab/ BHEL approved third party lab.
- b. Reference sample for each supplied lot shall be collected and tested at BHEL lab/BHEL approved lab, if required.
- c. In case, test results of the collected cement sample fail, the entire lot may be rejected and the supplier will have to make replacement of the entire lot at their own cost.

#### 11. PAYMENT TERMS

100% F.O.R price excluding GST shall be released within 90 days after receipt and acceptance of material at site and on submission of following documents:
