1. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small

Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. 1) Pre-Qualification Criteria (PQC):

1a) Prior Experience:

Bidder to submit at least one PO copy for centrifugal pump within last 5 years from the date of enquir y.

1b) Relaxation of Norms for Startups: The condition of Prior Turnover and prior experience is relaxed for all startups whether Micro & Small Enterprises (MSEs) or otherwise subject to meeting of quality and t echnical specifications in accordance with the relevant provision of GFR,2005 and other DOE-PPD notifica tions for relaxation norms for startups issued from time to time.

2) Payment term:

100% Basic payment shall be made within the stipulated days as mentioned below from the date of r eceipt and acceptance of material at BHEL Energy system facility, Nacharam, Hyderabad-500076 and submission of Performance Bank Guarantee (PBG).

GST will be reimbursed against submission of proof of payment of GST to govt. of India.

Type of bidder:

- A. For Micro & Small enterprises (MSEs) payment will be made within 45 days
- B. For Medium Enterprises will be made within 60 days
- C. Non MSMEs will be made within 90 days

However, GST Portion of Invoice shall be released only upon:

- i) Vendor declaring the Invoice in their GSTR-1.
- ii) Receipt of Goods and Tax Invoice by BHEL.
- iii) Confirmation of Payment of GST thereon by vendor on GSTN.
- 3) Compliance on restrictions under Rule 144 (XI) of the GFR: Submit the Annexure A which i s attached in buyer added bid specific ATC document.
- **4) Conflict of Interest Clause:** Submit the Annexure B which is attached in buyer added bid specific ATC document.
- **Technical Specification:** Bidder shall submit compliance on attached BHEL Technical specification (Annexure-1) uploaded in Buyer Specification Document.

6) Invoice registration and documents upload in SUVIDHA portal by suppliers

Irrespective of the value of the invoice amount, the bidder / vendor should necessarily upload the des patch & invoice details on BHEL SUVIDHA portal at https://suvidha.bhel.in/suvidha/, prior to despatc h.

All documents as per PO checklist, along with additional documents (if any), must be uploaded on the portal. It is mandatory that tax invoices with a net amount (including taxes) exceeding Rs five (5) la khs uploaded on the portal are digitally signed using a Class 3 Digital Signature Certificate (DSC) issued by a licensed Certifying Authority. Submission of invoice document in hard copy is allowed for invoices with a net amount (including taxes) equal to and upto Rs five (5) lakhs, in case they were not digitally signed and uploaded on the portal.

The material will not be accepted inside BHEL in absence of the above.

- 8) Vendor has to submit this GeM bid document duly signed and stamped on all pages. By submitting signed GeM bid document it affirms that vendor has accepted to all the terms and conditions mentio ned in this bid such as Payment terms, delivery period, Terms of Delivery, PBG, Interest of delayed s ubmission of PBG, Breach of contract, Remedies and Termination etc.
- 9) Insurance, loading/unloading from vendor site to BHEL Energy systems facility, C/o IICT pilot plant c hemical complex, Road no 7, Nacharam Industrial Area, Nacharam will be in vendor scope only. Vendor has to quote price(s) inclusive of GST, Transportation/Insurance, Loading/Unloading charges.
- 10) Breach of contract, Remedies and Termination: In case of breach of contract, wherever the value of security instruments like performance bank guarantee available with BHEL against the said con tract is at least 10% of the contract value, the same be encashed. In case the value of the security in struments available is less than 10% of the contract value, the balance amount be recovered from ot her financial remedies (i.e. available bills of the contract or, retention amount, etc. with BHEL) or leg al remedies be pursued. Further, levy of liquidated damages, debarment, termination, de scoping, s hort-closure, etc., shall be applied as per provisions of the contract.

11) Performance Bank Guarantee (PBG): PBG of 10% of total order value is to be submitted by the successful vendor within 15 days from the date of P.O. and shall be kept valid up to guarantee perio d. Expiry of claim period may be kept 3-6 months after validity date. PBG shall be from one of the Consortium banks of BHEL or from a reputed bank and confirmed by any Consortium bank of BHEL. The offers of the suppliers not accepting to this clause will be rejected.

12) Interest of delayed submission of PBG: Bidder has to submit performance bank guarantee (PB G) with-in 15 days from the date of receipt and acceptance of material at BHEL Energy systems facility, Nacharam- Hyderabad.

In case of delay in submission of PBG, enhanced performance security which would include interest (Repo rate + 4%) for the delayed period, shall be submitted by the bidder. Further, if performance security is not submitted till such time the first bill becomes due, the amount of performance security due shall be recovered as per terms defined in NIT/contract, from the bills along with due interest.

13) SFMS Confirmation of Bank Guarantees (BG):

Vendor/Contractor/Bidder to ensure that issuance of Bank Guarantee shall be confirmed by the issuin g Bank directly to the Owner mandatorily through Structured Financial Messaging System (SFMS), as it provides an RBI supported Integrated Platform for Bank Guarantee Verification.

SBI Bank has been designated as BHEL Corporate R&D's Bank for receiving SFMS messages for BGs i ssued in favour of BHEL Corporate R&D.

BG shall only be obtained from Banks and Branches which are live on SFMS platform i.e. which have i nfrastructure to issue SFMS confirmation message along with the BG.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of

bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.

- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
