- 1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

1 SCOPE OF WORK

SUPPLY OF 500 MT ORDINARY PORTLAND CEMENT (GRADE-43) AS PER IS 269:2015 AT 3×660 MW NORTH KARANPURA STPP FGD PROJECT, JHARKHAND.

SITE DETAILS:

3X660 MW North Karanpura Super Thermal Power Project (3x660 MW), a pit head coal based thermal pow er project, is located in Hazaribagh and Chatra districts of Jharkhand State.

OWNER: NTPC (National Thermal Power Corporation)

The power project is located near Tandwa town in Chatra districts in the state of Jharkhand on Hazaribagh-Chatra State highway at a distance of about 50 kms from Hazaribagh city. The nearest commercial airport is Ranchi at a distance of 150 kms from project site. The nearest railhead Khalari Railway Station on Ranch i-Garhwa section of Eastern Railways is about 40 kms from project site.

2 TAXES AND DUTIES:

- 2.1 Bidder's quoted/ accepted rates/ price shall be inclusive of all taxes including GST, Charges, Royalties, any State or Central Levy and other taxes for materials if any obtained for the work and for execution of the contract
 - Any increase of above at any stage during execution of contract, including extension of the contract, shall have to be borne by successful bidder contractor. However, any increase of GST subsequent to due date of offer submission as per NIT & TCN, by statutory authority during contract period (including extension, if the same is not attributable to you), shall be reimbursed by BHEL on production of relevant supporting document to the satisfaction of BHEL.
 - Benefit of any decrease of taxes including GST, Charges, Royalties, any State or Central Levy and oth er taxes for materials if any obtained for the work and for execution of the contract; subsequent to due date of offer submission as per NIT & TCN, by statutory authority shall be passed on to BHEL.
- 2.2 Successful bidder shall furnish proof of GST registration with GSTN Portal covering the services under this contract.
 - Registration should also bear endorsement for the premises from where the billing shall be done by su ccessful bidder on BHEL for this project / work.
- 2.3 Since GST on output will be paid by BHEL as enumerated above, bidder's quoted rates / price should b

- e after considering the Input Credit under GST law at bidder's end.
- 2.4 TDS under Income Tax Act shall be deducted as per prevailing IT rules from the bills.
- 2.5 TDS under GST shall be deducted as per prevailing GST rules from the bills.
- 2.6.1 You may collect TCS under section 206C(1H) of Income Tax Act, 1961 if applicable.
- 2.6.2 In case, you collect TCS under section 206C(1H) of Income Tax Act, 1961, following compliance is required.
- 2.6.2.1 TAN and PAN of vendor should appear in all invoices/claims. Copy of TAN /TCS registration is to be submitted.
- 2.6.2.2 Amount of TCS and Assessable value on which TCS has been calculated should be specified clearly in the invoice.
- 2.6.2.3 You shall be required to submit certificate of TCS in Form no. 27D within 15 days from the due date for furnishing the statement of tax collected at the source.

- 2.6.5 You shall comply with all statutory amendment/notifications in this respect.

- 2.8 Successful bidder to intimate immediately on the day of removal of goods (in case of any supply of go ods) to BHEL along with all relevant details and send a scanned copy of Tax Invoice to BHEL through f ollowing communication mode for enabling BHEL to meet its GST related compliances.
 - Portal address and Email address Shall be intimated later.
 - Specific details of above shall be intimated to successful bidder by BHEL at appropriate juncture.
- 2.9 In case of delay in submission of above-mentioned documents on the date of dispatch, BHEL may inc ur penalty/ interest for not adhering to Invoicing Rules under GST Law. The same will be liable to be r ecovered from successful bidder, in case such delay is not attributable to BHEL.
- 2.10 In case of raising any Supplementary Tax Invoice (Debit / Credit Note), successful bidder shall issue t he same containing all the details as referred to in Section 34 read with Section 31 of GST Act & Rules referred there under.
- 2.11 Successful bidder shall comply with the Time Limit prescribed under the GST Law and rules thereof fo r raising of the Tax Invoice. If any supply of goods is applicable, successful bidder shall also ensure pr ompt delivery of goods after dispatch.
- 2.12 Bidder shall note that in case GST credit is delayed / denied to BHEL due to delayed / non-receipt of g oods and / or Tax Invoice or expiry of the timeline prescribed in GST Law for availing such ITC, or any other reasons, not attributable to BHEL, GST amount shall be recoverable from successful bidder alon g with interest levied/ leviable on BHEL, as the case may be.
- 2.13 Successful bidder shall upload the invoices raised on BHEL in IFF/GSTR-1 within the prescribed time a s given in the GST Act, and the same should be available to BHEL in FORM GSTR-2B electronically thr ough the common portal; and confirmation of payment of such GST to the Government through filing of GSTR-3B of corresponding month/quarter.

5 SPECIAL INSTRUCTIONS

5.1 The unloading of cement will be done by BHEL at site within a reasonable time.

5.2 Site test of cement shall be conducted as per BHEL/Customer's field quality plan. ves the right to conduct necessary test at vendor's works if required.

- 5.3 The representative of the vendor should be available at North Karanpura site whenever required as per BHEL site requirement to provide single window expeditious service, joint sampling and quality checks as p er IS code.
- 5.4 Guarantee / Warranty certificate to be furnished by the successful bidder.
- 5.5 Quality of cement is associated with shelf life. Shelf life of cement supplied should be in line with IS sp ecification, considering manufacturing & transit time so that minimum 8 weeks' shelf life is available from the date of receipt at site, for use of BHEL. Bidder shall ensure supply of cement at site accordingly.
- 5.6 Copy of Manufacturer's test certificate in original for 7 & 28 days test result submitted by successful bi dder is to be accepted by BHEL/Customer.
- 5.7 Store Receipt Voucher shall be generated at site.
- 5.8 The material should be delivered in original manufacturer's temper proof sealed packing. Packing shall be in non-returnable 50 kg bags only.
- 5.9 Transit Insurance shall be in the scope of BHEL.

6 DOCUMENTS REQUIRED ALONG WITH DISPATCH OF MATERIAL

The following documents are required with dispatch:

- a) GST compliant Invoice (1 original plus 2 copies)
- b) Copy of Intimation to Insurance Company

7 INSPECTION

BHEL reserves the right to inspect/test the material during/after manufacturing at supplier's works, and/ or at BHEL site and also to get tested the material under dispatch from third party. The test results of thi rd-party test shall be final and binding on the vendor. In case of rejection at any stage, supplier shall be liable to replace at his own cost.

8 REJECTION

In case any material is found defective or unsuitable at our works/Site after supply, the same shall be subjected to test by third party and the result of the third-party test shall be acceptable and binding to the vendor. In case the test results show that the material does not conform to the standards specified, the whole lot shall be rejected, taken back by the vendor and replaced by the acceptable material at vendor's cost.

9 **OUALITY INSTRUCTION:**

- a. Manufacturer's Test certificate for 7 days & 28 days are to be submitted and to be accepted by BHEL Site before release of payment. Preliminary acceptance of Cement will be on the basis of 7 days test report as per MTC submitted by supplier. Final acceptance criteria will be 28 days test report as per s upplier's MTC or if required at BHEL lab/ BHEL approved third party lab.
- b. Reference sample for each supplied lot shall be collected and tested at BHEL lab/BHEL approved lab, if required.
- c. Supplier shall be available to carry out joint Sampling of Cement, if required.
- d. In case, test results of the collected cement sample fail, the entire lot may be rejected and the supplie r will have to do make replacement of the entire lot at their own cost.
