If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover, shall upload the supporting documents to prove his eligibility for exemption.
- 3. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 1) Pre-Qualification Criteria (PQC):

1a) Prior Experience: Bidder to submit at least one Purchase order copy for any chemical in last 5 years from the date of enquiry.

1b) Relaxation of Norms for Startups: The condition of Prior Turnover and prior experience is rel axed for all startups whether Micro & Small Enterprises (MSEs) or otherwise subject to meeting of qu ality and technical specifications in accordance with the relevant provision of GFR,2005 and other DO E-PPD notifications for relaxation norms for startups issued from time to time.

2) Payment term: 100% Basic payment shall be made within the stipulated days as mentioned belo w from the date of receipt and acceptance of material at BHEL Energy system facility, Nacharam, Hy derabad-500076.

GST will be reimbursed against submission of proof of payment of GST to govt. of India.

Type of bidder:

- A. For Micro & Small enterprises (MSEs) payment will be made within 45 days
- B. For Medium Enterprises will be made within 60 days
- C. Non MSMEs will be made within 90 days

However, GST Portion of Invoice shall be released only upon:

In case the value of the security in struments available is less than 10% of the contract value, the balance amount be recovered from ot her financial remedies (i.e. available bills of the contract or, retention amount, etc. with BHEL) or leg al remedies be pursued. Further, levy of liquidated damages, debarment, termination, de scoping, s hort-closure, etc., shall be applied as per provisions of the contract.

It is mandatory that tax invoices with a net amount (including taxes) exceeding Rs five (5) la khs uploaded on the portal are digitally signed using a Class 3 Digital Signature Certificate (DSC) issued by a licensed Certifying Authority. Submission of invoice document in hard copy is allowed for invoices with a net amount (including taxes) equal to and upto Rs five (5) lakhs, in case they were not digitally signed and uploaded on the portal.
