Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. Liquidated Damages, wherever referred under this Tender/Agreement, shall mean and refer to the damages , not in the nature of penalty, which the Supplier/Vendor agrees to pay in the event of delay in delivery of su pplies, breach of contract etc. as the case may be.

Liquidated Damages leviable upon the Supplier/Vendor is a sum which is agreed by the parties as a reasona ble and genuine pre-estimate of damages which will be suffered by BHEL on account of delay/breach on the part of the Supplier/Vendor.

If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for

the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period, until actual delivery or performance, as pre-estim ated damages not exceeding 5% of the total contract value without any controversy/dispute of any sort wha tsoever. However, in case of inordinate delay maximum deduction shall be 10% of the total contract value.

Note: Inexcusable delays of more than one-fourth (25%) of the completion period specified in the contract shall be treated as inordinate delay(s).

27. Evaluation Criteria: Evaluation shall be done on total cost to BHEL basis. 28. Breach of contract, remedies and termination

(A) Breach of contract and Termination:

Following conditions shall be considered as breach of contract:

- a) Non-supply of material/ non-completion of work by the Supplier/Vendor within scheduled delivery/ completion period as per contract or as extended from time to time.
- b) The Supplier/Vendor fails to perform as per the activity schedule and there are sufficient reasons even before expiry of the delivery/ completion period to justify that supplies shall be inordinately delayed bey ond contractual delivery/ completion period.
- c) The Supplier/Vendor delivers equipment/ material not of the contracted quality.
- d) The Supplier/Vendor fails to replace the defective equipment/ material/ component as per guarantee cl ause.
- e) Withdrawal from or abandonment of the work by the Supplier/Vendor before completion as per contrac t.
- f) Assignment, transfer, subletting of Contract by the Supplier/Vendor without BHEL's written permission resulting in termination of Contract or part thereof by BHEL.
- g) Non-compliance to any contractual condition or any other default attributable to Supplier/Vendor.
- h) Any other reason(s) attributable to Vendor towards failure of performance of contract. In case of breach of contract, BHEL shall have the right to terminate the Purchase Order/ Contract either in whole or in par t thereof without any compensation to the Supplier/Vendor.
- i) Any of the declarations furnished by the contractor at the time of bidding and/ or entering into the cont ract for supply are found untruthful and such declarations were of a nature that could have resulted in n on-award of contract to the contractor or could expose BHEL and/ or Owner to adverse consequences, fi nancial or otherwise.
- j) Supplier/Vendor is convicted of any offence involving corrupt business practices, antinational activities or any such offence that compromises the business ethics of BHEL, in violation of the Integrity Pact ente red into with BHEL has the potential to harm the overall business of BHEL/ Owner.

Note-Once BHEL considers that a breach of contract has occurred on the part of Supplier/Vendor, BHEL shall notify the Supplier/Vendor by way of notice in this regard. Contractor shall be given an opportunity to rectify the reasons causing the breach of contract within a period of 14 days.

In case the contractor fails to remedy the breach, as mentioned in the notice, to the satisfaction of BHEL, BH EL shall have the right to take recourse to any of the remedial actions available to it under the relevant provisions of contract.

(B) Remedies for breach of contract:

In case of Breach of Contract, BHEL shall recover 10% amount of the contract value from the vendor in following manners:

- (i) Wherein the period as stipulated in the notice issued under clause 31.1 has expired and Supplier/Ven dor has failed to remedy the breach, BHEL will have the right to terminate the contract on the ground of "Breach of Contract" without any further notice to contractor.
- (ii) Upon termination of contract, BHEL shall be entitled to recover an amount equivalent to 10% of the C ontract Value for the damages on account of breach of contract committed by the Supplier/Vendor. Thi

- s amount shall be recovered by way of encashing the security instruments like performance bank guar antee etc available with BHEL against the said contract. In case the value of the security instruments a vailable is less than 10% of the contract value, the balance amount shall be recovered from other finan cial remedies (i.e. available bills of the Supplier/Vendor, retention amount, from the money due to the Supplier/Vendor etc. with BHEL) or the other legal remedies shall be pursued.
- (iii) wherever the value of security instruments like performance bank guarantee available with BHEL agai nst the said contract is 10% of the contract value or more, such security instruments to the extent of 1 0% contract value will be encashed. In case no security instruments are available or the value of the s ecurity instruments available is less than 10% of the contract value, the 10% of the contract value or t he balance amount, as the case may be, will be recovered in all or any of the following manners:
- (iii.1) In case the amount recovered under clause above is not sufficient to fulfil the amount recoverable the n; a demand notice to deposit the balance amount within 30 days shall be issued to Supplier/Vendor.
- (iii.2) If Supplier/Vendor fails to deposit the balance amount within the period as prescribed in demand notic e, following action shall be taken for recovery of the balance amount:
 - a) from dues available in the form of Bills payable to defaulted Supplier/Vendor against the same contract.
 - b) If it is not possible to recover the dues available from the same contract or dues are insufficient to meet the recoverable amount, balance amount shall be recovered from any money(s) payable to S upplier/Vendor under any contract with other Units of BHEL including recovery from security depos its or any other deposit available in the form of security instruments of any kind against Security d eposit or EMD.
 - c) In-case recoveries are not possible with any of the above available options, Legal action shall be i nitiated for recovery against defaulted supplier/Vendor.
- (iv) It is an agreed term of contract that this amount shall be a genuine pre-estimate of damages that BH EL would incur in completion of balance contractual obligation of the contract through any other agenc y and BHEL will not be required to furnish any other evidence to the Supplier/Vendor for the purpose of estimation of damages.
- (v) In addition to the above, imposition of liquidated damages, debarment, termination, de-scoping, short -closure, etc., shall be applied as per provisions of the contract.
 - **Note:** 1. The defaulting Supplier/Vendor shall not be eligible for participation in any of the futu re enquiries floated by BHEL to complete the balance work. The defaulting contractor shall me an and include:

30. ADJUSTMENT OF RECOVERY:

Any amount payable by the Supplier / Contractor under any of the condition of this contract shall be liable to be adjusted against any amount payable to the Supplier / Contractor under any other Purch ase Order / Contract awarded to him by any BHEL unit. This is without prejudice to any other action, as may be deemed fit, by BHEL.

Settlement of Dispute

If any dispute or difference of any kind whatsoever shall arise between BHEL and the Supplier/Vendo r, arising out of the contract for the performance of the work whether during the progress of contract termination, abandonment or breach of the contract, it shall in the first place referred to Designated Engineer for amicable resolution by the parties. Designated Engineer (to be nominated by BHEL for s ettlement of disputes arising out of the contract) who within 60 days after being requested shall give written notice of his decision to the contractor. Save as hereinafter provided, such decision in respect of every matter so referred shall forthwith be given effect to by the Supplier/Vendor who shall proceed with the work with all due diligence, whether he or BHEL desires to resolve the dispute as herein after provided or not.

If after the Designated Engineer has given written notice of this decision to the party and no intentio n to pursue the dispute has been communicated to him by the affected party within 30 days from the receipt of such notice, the said decision shall become final and binding on the parties. In the event the Supplier/Vendor being dissatisfied with any such decision or if amicable settlement cannot be reached then all such disputed issues shall be resolved through conciliation in terms of the BHEL Conciliation Scheme 2018 as per Clause 21.1

31.1 Conciliation:

Any dispute, difference or controversy of whatever nature howsoever arising under or out of or in rel ation to this Agreement (including its interpretation) between the Parties, and so notified in writing b

y either Party to the other Party (the "Dispute") shall, in the first instance, be attempted to be resolv ed amicably in accordance with the conciliation procedure as per BHEL Conciliation Scheme 2018. The proceedings of Conciliation shall broadly be governed by Part-III of the Arbitration and Conciliation Act 1996 or any statutory modification thereof and as provided in – "Procedure for conduct of conciliation proceedings" (as available in www.bhel.com).

Note: Ministry of Finance has issued OM reference No. 1/2/24 dated 03.06.2024 regarding "Guidelin es for Arbitration and Mediation in Contracts of Domestic Public Procurement. In the said OM it has b een recommended that Government departments/ Entities/agencies are to encourage mediation un der the Mediation Act. 2023. The said Act has not yet been notified by the Government. Therefore, t he clause "Settlement of Disputes" shall be modified accordingly as and when the Mediation Act 202 3 gets notified.

31.2 ARBITRATION:

- a) Except as provided elsewhere in this Contract, in case Parties are unable to reach amicable settle ment (whether by Conciliation to be conducted as provided in Clause 21.1 herein above or otherwis e) in respect of any dispute or difference; arising out of the formation, breach, termination, validity o r execution of the Contract; or, the respective rights and liabilities of the Parties; or, in relation to int erpretation of any provision of the Contract; or. In any manner touching upon the Contract (hereinaft er referred to as the 'Dispute'), then, either Party may, refer the disputes to Arbitral Institution, ie. "Il AC" (India International Arbitration Centre) and such dispute to be adjudicated by Sole Arbitrator ap pointed in accordance with the Rules of said Arbitral Institution.
- b) A party willing to commence arbitration proceeding shall invoke Arbitration Clause by giving notice to the other party in terms of section 21 of the Arbitration & Conciliation Act, 1996 (hereinafter referred to as the 'Notice') before referring the matter to arbitral institution. The Notice shall be addressed to the Head of the Region, Power Sector/ Unit, BHEL, executing the Contract and shall contain the particulars of all claims to be referred to arbitration with sufficient detail and shall also indicate the monetary amount of such claim including interest, if any.
- c) After expiry of 30 days from the date of receipt of aforesaid notice, the party invoking the Arbitratio n shall submit that dispute to the Arbitral Institutions ie. "IIAC" (India International Arbitration Centre) and that dispute shall be adjudicated in accordance with their respective Arbitration Rules. The matter shall be adjudicated by a Sole Arbitrator who shall necessarily be a Retd Judge having consider able experience in commercial matters to be appointed/nominated by the respective institution. The cost/expenses pertaining to the said Arbitration shall also be governed in accordance with the Rules of the respective Arbitral Institution. The decision of the party invoking the Arbitration for reference of dispute to a specific Arbitral institution for adjudication of that dispute shall be final and binding on both the parties and shall not be subject to any change thereafter. The institution once selected at the time of invocation of dispute shall remain unchanged.
- d) The fee and expenses shall be borne by the parties as per the Arbitral Institutional rules.
- e) The Arbitration proceedings shall be in English language and the seat and venue of Arbitration shall be New Delhi.
- f) Subject to the above, the provisions of Arbitration & Conciliation Act 1996 and any amendment there of shall be applicable. All matters relating to this Contract and arising out of invocation of Arbitration clause are subject to the exclusive jurisdiction of the Court(s) situated at New Delhi.
- Motwithstanding any reference to the Designated Engineer or Conciliation or Arbitration herein, a. the parties shall continue to perform their respective obligations under the Contract unless they otherwise agree. Settlement of Dispute clause cannot be invoked by the Contractor, if the Contract has been mutually closed or 'No Demand Certificate' has been furnished by the Contractor or any Settlement Agreement has been signed between the Employer and the Contractor.
- h) It is agreed that Mechanism of resolution of disputes through arbitration shall be available only in the cases where the value of the dispute is less than Rs. 10 Crores.
- In case the disputed amount (Claim, Counter claim including interest is Rs. 10 crores and above, the e parties shall be within their rights to take recourse to remedies other than Arbitration, as may be a vailable to them under the applicable laws after prior intimation to the other party. Subject to the af oresaid conditions, provisions of the Arbitration and Conciliation Act, 1996 and any statutory modifications or re-enactment thereof as amended from time to time, shall apply to the arbitration proceeding

	ngs under this clause.
j)	In case, multiple arbitrations are invoked (whether sub-judice or arbitral award passed) by any part y to under this contract, then the cumulative value of claims (including interest claimed or awarded) in all such arbitrations shall be taken in account while arriving at the total claim in dispute for the su bject contract for the purpose of clause 21.2.9.
