- 1) Pre-Qualification Criteria (PQC):
- **1a) Prior Experience:** Bidder to submit at least one Purchase order copy for separator/centrifuge decanter in last 5 years from the date of enquiry

1b) Relaxation of Norms for Startups:

The condition of Prior Turnover and prior experience is relaxed for all startups whether Micro & Small Enterprises (MSEs) or otherwise subject to meeting of quality and technical specifications in accordance with the relevant provision of GFR,2005 and other DOE-PPD notifications for relaxation norms for startups issued from time to time.

2) Payment term: 100% Basic payment shall be made within the stipulated days as mentioned belo w from the date of receipt and acceptance of material at BHEL Energy system facility, Nacharam, Hy derabad-500076 and submission of Performance Bank Guarantee (PBG).
