1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to extant Order / Office Memorandum issued.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category in the extant Order / Office Memorandum issued.

4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying

The seller is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
