1. The battery supply condition (factory charged), material and construction, separators, terminal post, cell lids, plates, electrolyte, connector, designation of cells, charger, flame arrestor, and marking requirements shall conform to the IS 15549 standard.

1a) Prior Experience:

Vendor should submit at least one PO copy for batteries which were supplied within last 5 years from the date of Enquiry.

1c) Relaxation of Norms for Startups:

The condition of Prior Turnover and prior experience is relaxed for all startups whether Micro & Small Enterprises (MSEs) or otherwise subject to meeting of quality and technical specifications in accordance with the relevant provision of GFR,2005 and other DOE-PPD notifications for relaxation norms for startups issued from time to time.

2) Payment term: 100% basic payment shall be made within stipulated days as mentioned below from the date of completion of entire scope (i.e supply & installation) subject to acceptance at BHEL Energy system facility, Nacharam, Hyderabad-500076 against submission of GST-compliant Invoice.
