- e.** Self-Certification for local content declaration as per enclosed format.
- f.** No Deviation Certificate as per enclosed format
- g.** Signed and Stamped enclosed declaration regarding conflict of interest
- h.** Declaration regarding compliance to restrictions under Rule 144 (xi) of GFR

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority.
