Following terms and conditions supersede all existing "Buyer added Bid Specific Terms and conditions" given in the bid document or any previous corrigendum. Prospective bidders are advised to bid as per following Terms and Conditions:

Buyer Added Bid Specific Additional Terms and Conditions

1. AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.
2. Bidder shall submit the following documents along with their bid for Vendor Code Creation:
 - a. Copy of PAN Card.
 - b. Copy of GSTIN.
 - c. Copy of Cancelled Cheque.
 - d. Copy of EFT Mandate duly certified by Bank.
3. Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.
4. Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.
5. Buyer Added text based ATC clauses
 - I) Average annual turnover of the contractor duly certified by a practitioner chartered accountant during the last 3 years ending 31st March 21 should be at least 30% of the estimated value. (i.e. ₹1,03,000/). Tenderer should enclose EPF, ESI, PAN, GSTIN New registration no., Income tax returns for last three years (AY 2018-19, 2019-20 & 2020-21) and Profit & Loss account and Balance Sheet certified by the Practicing Chartered Accountant for the last 3 years.
 - II) The Contractor should have experience in completion of similar works during the last 7 years ending 30.11.2021 as given below: -
 - (a) Three similar completed works costing not less than the amount equal to 40% of the estimated value (i.e. ₹ 1,37,500/- each)
 - (OR)**
 - (b) Two similar completed works costing not less than the amount equal to 50% of the estimated value (i.e. ₹ 1,71,500/- each).
 - (OR)**
 - (c) One similar completed work costing not less than the amount equal to 80% of the estimated value (i.e. ₹ 2,74,500 /-).

Work orders & Job Completion Certificates reflecting work orders and amount from the customer shall be enclosed in support of successful and satisfactory completion of the orders.

Note: Similar work means carrying out Inspection, Testing and Re-conditioning of Gas Cylinders in State / Central Govt. or Undertakings or Private firms.

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization. Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specification and / or terms and conditions governing the bid. Any clause incorporated by the Buyer such as demanding Tender Sample, incorporating any clause against the MSME policy and Preference to make in India Policy, mandating any Brand names or Foreign Certification, changing the default time period for Acceptance of material or payment timeline governed by OM of Department of Expenditure shall be null and void and would not be considered part of bid. Further any reference of conditions published on any external site or reference to external documents / clauses shall also be null and void.
