Buyer Added Bid Specific Additional Terms and Conditions

- 1. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.
- 2. **Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.
- 3. Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.
- 4. Bidder shall submit the following documents along with their bid for Vendor Code Creation:
 - a. Copy of PAN Card.
 - b. Copy of GSTIN.
 - c. Copy of Cancelled Cheque.
 - d. Copy of EFT Mandate duly certified by Bank.
- 5. Buyer Organization specific Integrity Pact shall have to be complied by all bidders. Bidders shall have to upload scanned copy of signed integrity pact as per Buyer organizations policy along with bid. Click here to view the file
- 6. Installation, Commissioning, Testing, Configuration, Training (if any which ever is applicable as per scope of supply) is to be carried out by OEM / OEM Certified resource or OEM authorised Reseller.
- 7. Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:
 - i) The Seller fails to comply with any material term of the Contract.
 - ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
 - iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
 - iv) The Seller becomes bankrupt or goes into liquidation.
 - v) The Seller makes a general assignment for the benefit of creditors.
 - vi) A receiver is appointed for any substantial property owned by the Seller.
 - vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.
- 8. 1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
 - 2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
 - 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due

performance of the Contract and the Sellers obligations there under.

A.1 Transit Insurance: In BHEL Scope.

Insurance details shall be informed later.

Prior Dispatch intimation shall be issued to Insurance agency about the value of consignment, dispatch de tails, along with one set of documents consisting of LR / RR copy, Packing List, Challan indicating the item s dispatched (with their weights).

A.2 Guarantee period:

Twenty-Four (24) calendar months from the date of satisfactory completion of the Performance Guarantee Test.

A.3 Delivery Schedule:

Supply-Main Equipment-6 Months from manufacturing clearance

Supply-Mandatory Spares-3 Months from BHEL clearance

Supervision: Vendor to depute their representative as per the requirement mentioned in the

respective Technical Enquiry Specifications. Bidder to depute their representative on intimation from BHE L as per the requirement. Bidder's supervisor may be required to make multiple visits to ensure that erect ion/testing/commissioning of DG Set is completed in all respect.

Training: As per requirement mentioned in Technical Enquiry Specifications.

A.4 Submission of Performance Bank Guarantee (PBG):

The PBG shall be 3% of Order/ Contract value.

Validity of the Bank Guarantee shall be for the entire Guarantee period + claim period as per RBI guidelin es (min. 3 months). Initially, it should be at least 58 months + claim period as per RBI guidelines(min. 3 months), later extended to cover the guarantee period, two months before its expiry.

Bidder to submit performance security required for execution of the contract within 15 days from the date of Contract award. In case of delay in submission of performance security, enhanced performance security which would include interest (SBI rate + 6%) for the delayed period, shall be submitted by the bidder.

Further, if performance security is not submitted till such time the first bill becomes due, the amount of performance security due shall be recovered from the bills along with due interest.

A.5 Price Basis:

Type of Contract: Unit Rate, Firm till the completion of contract.

Evaluation Criteria: On total landed cost to BHEL basis

Total cost = Ex-Works price (inclusive of packing & forwarding charges) + freight charges + Applicable Ta xes & duties - Applicable input tax credit

Input tax credit is availed for GST, hence the same is excluded for arriving at the landed cost. Goods & Ser vice Tax (GST) is payable extra at actuals.

Terms of Delivery: Delivery shall be on Ex Works.

Insurance shall be in BHEL scope.

Transportation of goods up to Destination shall be arranged by vendor.

Freight Charges: Shall be payable on pro rata basis based on the Ex-works price (excluding freight & GST)

Payment shall be made on pro-rata basis as per approved billing break up(if applicable) as per payment terms mentioned below:

- (i) Ninety Five (95%) of ex works price of materials supplied, as per approved billing schedule, along with 100% GST (as applicable), shall be payable against clean receipted LR/ proof of receipt at site on pro-rata basis.
- (ii) Five (05%) of the total ex works price of materials shall be released after submission of all final documents as per Technical Specifications and succes sful completion of the Performance Guarantee (PG)/Demonstration Test at si te/ handing over to BHEL/ BHEL's Customer.

Collection of Material Receipt Certificate from Site/ Owner and its submission for claiming the payment shall be the responsibility of the Seller/ Contractor.

Certification of Performance Guarantee (PG)/ Demonstration Test at site/ handing over of all machines (i.e . completion of entire scope of work) Shall be by BHEL SITE-RM.

1.If the PG test is not conducted up to 24 months after completion of all main supplies for the entire scope of this Package, for reasons not attributable to the vendor/ contractor, the last 5% payment will be released against Bank Guarantee of an equivalent amount, valid initially for 12 months and extendable till completion of Performance Guarantee (PG)/ Demonstration Test at site/ handing over of this Package. No i nterest, whatsoever, shall be payable by the purchaser on the any Bank Guarantee/ security submitted or any amount due to the seller/ contractor.
