3. Bidder shall submit the following documents along with their bid for Vendor Code Creation:

 - c. Copy of Cancelled Cheque.
 - d. Copy of EFT Mandate duly certified by Bank.
4. Products supplied shall be nontoxic and harmless to health. In the case of toxic materials, Material Safety Data Sheet may be furnished along with the material.
5. Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.
