1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating

to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

- 2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. - 3. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
  - i. If number of technically qualified bidders are only 2 or 3.
  - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
  - iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
  - iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
  - v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

# Buyer Added Bid Specific Terms and Conditions/क्रेता द्वारा जोड़ी गई बिड की विशेष शर्तें

### 1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- **1a) Qualifying Criteria [PQC]:** Supplier/OEM shall provide at least one order copy with reference to supply of SF6 gas analyser/multi analyser for circuit breaker/gas insulated substation equipment within last seven years from the date of this enquiry.
- **1b) Relaxation of Norms for Startups:** The condition of Prior Turnover and prior experience is relaxed for all startups whether Micro & Small Enterprises(MSEs) or otherwise subject to meeting o f quality and technical specifications in accordance with the relevant provision of GFR,2005 and ot her DOE-PPD notifications for relaxation norms for start-ups issued from time to time.
- **2) Payment term:** 80% payment of the supply value shall be made within stipulated time as me ntioned below from the date of receipt of material with clear documents at BHEL. Balance 20% of su pply value plus 100% of the E&C portion of PO Value will be paid against E&C certificate issued by BHEL a nd submission of Performance Bank Guarantee by supplier.

## Stipulated time based on Type of the bidder:

- A. For Micro & Small enterprises(MSEs) payment will be made with-in 45 days
- B. For Medium Enterprises will be made with-in 60 days
- C. Non MSMEs will be made with-in 90 days

However, GST Portion of Invoice shall be released only upon:

- i) Vendor declaring the Invoice in their GSTR-1.
- ii) Receipt of Goods and Tax Invoice by BHEL.
- iii) Confirmation of Payment of GST thereon by vendor on GSTN portal.
- **3)** Contract execution Bank Guarantee(CEBG): The successful vendor shall have to furnish a Contract Execution Bank Guarantee (CEBG) for **10% of the Total PO value** in the prescribed for mat **within 30 days from the date of P.O**. CEBG shall be from one of the Consortium Banks of BHEL or from a reputed Bank and confirmed by any Consortium Bank of BHEL. All bank charges on

account of issuance and conformation of CEBG will have to be borne by the vendor.

CEBG shall be kept valid unit 30 days after the date of ICT Certificate, which will be issued on completion of Installation & Commissioning of equipment which includes Installation, commissioning a nd training to operators etc. as prescribed in PO.

If the supplier fails to submit the CEBG even with-in 60 days from the date of PO, BHEL reserves the right to cancel PO & forfeit the EMD given by the supplier. In addition, in such case, action will be initiated in line with extant guidelines for Suspension of Business dealings with Suppliers.

Under all circumstances, CEBG shall be kept valid till be PBG becomes operational.

Note: Proforma of Contract Execution Bank Guarantee (CEBG) is attached in ATC documents (refer page no. 2 to 4).

**4) Interest of delayed submission of ePBG and CEBG:** Bidder agrees to submit Contract Exec ution Bank Guarantee(CEBG) with-in 30 days from the date of P.O and performance bank guarante e (ePBG) with-in 15 days from the date of completion of commissioning.

In case of delay in submission of PBG and CEBG, enhanced performance security which would include interest (SBI rate + 6%) for the delayed period, shall be submitted by the bidder. Further, if performance security is not submitted till such time the first bill becomes due, the amount of performance security due shall be recovered as per terms defined in NIT/contract, from the bills along with due interest.

- **5a) Delivery period:** The delivery period 180 (from PO) is for complete scope of contract (Suppl y, I & C and training etc.)
- **5b)** Vendor to complete Installation, commissioning and training (ICT) activities within 30 days aft er site readiness communication from BHEL. BHEL will furnish the clearance for ICT within 20 days from the date of receipt of item at BHEL R & D as per tender specifications.

#### 6) Penalty for Delay in supply and commissioning:

- 6a) For the purpose of penalty for delay in commissioning of the SF6 Gas Analyzer the duration will be reckoned from the date of intimation by BHEL to vendor for readiness of site.
- 6b) Penalty on delay in 'Supply' and/or 'commissioning 'will be applicable to the delays attributed to vendor.

Penalty will be considered separately for 'Supply' and 'commissioning'.

The rate of penalty for delayed Supply shall be @ 0.5% per week of delay of total PO value

(Supply+ Commissioning) in supply subject to a maximum of 10% of total PO value (Supply+ commissioning).

The rate penalty for delayed commissioning shall be @0.5% per week of delay of total PO Value (S upply+ commissioning) in commissioning subject to a maximum of 10% of total PO value (Supply+ commissioning). Maximum penalty for delay in Supply and commissioning together shall be limited to 15% of total PO value (Supply+ commissioning).

6C) Incase, any shortage is noticed viz-a-viz PO requirement in the main SF6 Gas Analyser, such shortages shall be replenished by supplier on for destination basis without any cost implication to BHEL i.e. Custom Duty and freight charges etc. up to destination for such short supplies shall be b orne by the supplier.

- 7) Restriction: Submit the Annexure A which is attached in ATC document (refer page no. 1).
- 8) Vendor to Confirm Acceptance to Technical specification attached in ATC document page 5.
- **9)** Vendor has to submit this GeM bid document duly signed and stamped on all pages. By submitt ing singed Gem bid document it affirms that vendor has accepted to all terms and conditions men tioned in this bid such as payment terms, EMD, PBG,CEBG, Delivery period, Penalty clause etc.

- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
